The Islington (Prescribed Routes) (No. 96) Traffic Order 1994 Relating to Ecclesbourne Road N.1

Notice is hereby given that the London Borough of Islington, proposes to make the above-mentioned Order under section 6 of and part III of Schedule 9 to the Road Traffic Regulations Act 1984, as amended by the Local Government Act 1985.

The Cycle Lane, subject of this notice, has been in existence for some time, but no formal Traffic Order was ever made.

The proposed Order; the subject of this notice will regularise the position and make the Ecclesbourne Road Cycle Lane lawful.

The general effect of the Order would be to create a segregated cycle lane, known as the "Ecclesbourne Road Cycle Lane" being the area of carriageway coloured red which lies within that length of Ecclesbourne Road, in the London Borough of Islington, from its junction with New North Road and which extends along Ecclesbourne Road, on the south-eastern kerb-line only, for a length of 27 metres.

(a) No vehicle, other than pedal cycles, will be allowed to enter, proceed or wait in the Ecclesbourne Road Cycle Lane except for any vehicles wishing to enter or exit from the entrance to the property known as 272-280 New North Road; that entrance being situated in Ecclesbourne Road. Nothing in this article shall apply to a pedal-cycle entering the Ecclesbourne Road Cycle Lane at its north-eastern extremity.

(b) Within the "Ecclesbourne Road Cycle Lane" pedal cycles will be allowed to travel in a south-westerly direction only.

(c) Within that area of carriageway which lies within that length of Ecclesbourne Road, from its junction with New North Road, and which extends along Ecclesbourne Road, on the northwestern kerb-line only, for a length of 27 metres; all vehicles, including pedal-cycles, will be allowed to travel in a northeasterly direction only.

(d) The sole exception to items (a) (b) and (c) above will be to allow vehicles, of any type, to enter or exit from the entrance to the property known as 272-280 New North Road; that entrance being situated in Ecclesbourne Road.
