

- (c) for local authority, North West Water Limited and Post Office purposes;
- (d) if the vehicles are fire service or police vehicles or ambulances;
- (e) to take on fuel, water or air at any garage; or
- (f) for delivery or collection of goods and for loading or unloading.

The Order will also have the effect of revoking the Wigan Borough Council (Castle Hill Road, Hindley) (Prohibition of Waiting and Restriction of Loading/Unloading) Order 1993, so far as it relates to the prohibition of waiting and restriction of loading/unloading on Castle Hill Road, Hindley, from a point 15 metres north-east of Close Street, for a distance of 35 metres in an easterly direction.

A copy of the proposed Order, must be made in writing and specify the grounds thereof, and must be made to the Borough Solicitor, New Town Hall, Library Street, Wigan, not later than 20th December 1994.

NORTH YORKSHIRE COUNTY COUNCIL

The North Yorkshire County Council (Prohibition, Restriction and Limitation of Waiting) (Various Roads, Filey) Variation Order 1994.

Notice is hereby given that North Yorkshire County Council proposes to make an Order under sections 1(1), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984, the effect of which will be to vary the "North Yorkshire County Council (Prohibition, Restriction and Limitation of Waiting) (Various Roads, Filey) Order 1992" and "The Council of the County of North Yorkshire

(Consolidated and Prohibition and Restriction of Waiting) (Filey) Order 1986 as follows:

- (i) To revoke in their entirety the restrictions relating to Crescent Hill, Filey as specified in Part V of the Schedule to the 1992 Order.
- (ii) To limit the waiting of vehicles on the south side of Murray Street from its junction with John Street to its junction with West Avenue, already referred to in the 1992 Order to one hour, return prohibited within two hours, between the hours of 10 a.m. and 6 p.m. Monday to Saturday inclusive but lifting the restrictions on Sundays.
- (iii) To vary the waiting restrictions on vehicles on the lengths of roads specified in Article 8 and Schedule III of the 1986 Order to waiting between the hours of 10 a.m. and 6 p.m. during the period 21st March to 30th September and no longer between 10 a.m. and 7 p.m. from Good Friday to 30th September.
- (iv) To vary the waiting restrictions on vehicles on the lengths of roads specified in Article 9 and Schedule IV of the 1986 Order to waiting between the hours of 10 a.m. and 6 p.m. Monday to Saturday inclusive.

A copy of the draft Order, together with the map showing the roads affected and a statement of the Council's reasons for proposing to make the Order may be inspected at County Hall, Northallerton and at Filey Library, Southdene, Filey, North Yorkshire, during normal office hours.

If you wish to object to the proposed Order you should send the grounds for your objection, in writing addressed to the County Secretary, Room 7, County Hall, Northallerton DL7 8AD, by 16th December 1994.
