*The District of Basildon (Off-Street Parking Places)
(Consolidation) (Amendment No. 1) Order 1994*

Notice is hereby given that the District Council of Basildon pursuant to sections 35(1) and (3) of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to that Act and all other enabling powers, after consultation and with the consent of Essex County Council, as provided by section 39(3) of the Act and after consulting the Chief Officer of Police for Essex County Council in accordance with Part III of Schedule 9 of the Act, and of all other enabling powers, made an Order on 22nd November 1994, to amend car parking charges at the Basildon Centre Surface Level Car Park, Basildon, the effect of which is as follows:

In respect of the season ticket charge, there will be no change made to the current charge of £90 per quarter year, inclusive of Value Added Tax.

If you wish to question the Order or any provisions contained in it on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or any Instrument made under it, has not been complied with in relation to the Order, you may within 6 weeks from 22nd November 1994, apply to the High Court for this purpose.

This Order will come into operation on 28th November 1994.

(Ahead only) and (Dukes Ride Service Road, Crowthorne)
(Revocation of Waiting Restrictions) Order 1994.*

*Royal County of Berkshire ((A321) Twyford Road, Wokingham)
(Restricted Road and 40 m.p.h. Speed Limit) Order 1994*

Notice is hereby given that the County Council of the Royal County of Berkshire proposes to make an Order under sections 82(2), 83(2), 84(1) and (2) of the Road Traffic Regulation Act 1984, the effect of which is to:

1. Prohibit any vehicle from proceeding at a speed exceeding 40 m.p.h. in any direction along the A321 Twyford Road, Wokingham between a point 90 metres north of its junction with Bell Foundry Lane to a point 148 metres north of its junction with Matthewsgreen Road, a distance of 394 metres.
2. Prohibit any vehicle from proceeding at a speed exceeding 30 m.p.h. in any direction on the A321 Twyford Road, Wokingham between a point 148 metres and a point 61 metres north of its junction with Matthewsgreen Road, a distance of 87 metres.

All distances are approximate.
