

HEREFORD AND WORCESTER COUNTY COUNCIL

The County of Hereford and Worcester (Mill Street, Kidderminster) Various Orders 1994

Notice is hereby given that Hereford and Worcester County Council are to consider making an Order which will:

- A. prohibit waiting at any time on the south side of Mill Street, Kidderminster from a point 5 metres east of its junction with the access to Margaret Thatcher House to a point 5 metres west of that junction; and
- B. prohibit any vehicle, except public service vehicles, from waiting between the hours of 7 a.m. and 7 p.m. at any marked bus stops in Mill Street, Kidderminster from its junction with the Ring Road to its junction with Carpet Traders Way.

The Order will contain exemptions to allow parking for certain purposes.

The County of Hereford and Worcester (Abbey Road/Melen Street, Redditch) (Prohibition of Waiting) Order 1994

Notice is hereby given that on 17th November 1994 Hereford and Worcester County Council made an Order which will remove the existing limited waiting on both sides of Abbey Road/Melen Street, Redditch and replace it with a prohibition of waiting at any time on the north side between the boundaries of Nos. 43 and 45 and Nos. 28 and 30 to keep the bend clear of parked vehicles. The Order will come into operation of 29th November 1994.

The Order contains exemptions to allow parking for certain purposes and limited waiting by disabled persons vehicles.

A copy of the Order, relevant map, statement of reasons for making the Order and affected existing regulations may be inspected at County Hall, Spetchley Road, Worcester WR5 2NP, during normal office hours.

The validity of the Council's powers in making the Order or this exercise of them may be questioned by application to the High Court by 29th December 1994.

The Hertfordshire (South Street, Potter Street and Market Street, Bishop's Stortford) (20 m.p.h. Speed Limit) Order 1994

Notice is hereby given that the Hertfordshire County Council intend to introduce a permanent 20 m.p.h. speed limit on that length of South Street, Potter Street and Market Street, Bishop's Stortford from South Street's junction with Station Road and Newtown Road northwards to Market Street's junction with Bridge Street.

HERTFORDSHIRE COUNTY COUNCIL

The Hertfordshire (High Street, Church Lane and Water Lane, Berkhamsted) (Waiting, Loading and Unloading Restrictions) Order 1994.

Notice is hereby given that the Hertfordshire County Council have made an Order under sections 1(1), 2(1) to (3) of the Road Traffic Regulation Act 1984, the effect of which is to introduce waiting, loading and unloading restrictions in the lengths of High Street, Church Lane and Water Lane, Berkhamsted, as specified in the 4 Schedules to the notice.

Exemptions will apply as specified to enable persons to board or alight, for goods to be loaded and unloaded, statutory duties or the emergency services or disabled persons vehicles to be parked.

A copy of the Order which comes into operation on 4th December 1994, together with a statement of reasons for making the Order and a plan showing the roads to which the Order relate, may be inspected at the Dacorum Borough Council Offices, at the Civic Centre, Hemel Hempstead, and at the Cash Offices, Civic Centre, Berkhamsted, and the Hertfordshire County Council's Offices, at Room 223A, County Hall, Hertford.

Any person wishing to question the validity of the Order, or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or any Instrument made under it, has not been complied with in relation to the Order, may within 6 weeks from the date of this notice, apply to the High Court for this purpose.

SCHEDULE 1

Lengths of roads in Berkhamsted

No waiting at any time. No loading or unloading at any time

High Street, both sides of main carriageway, from its junction with Manor Street westwards to a point 60 metres north-west of the centre line of Kings Road.

Church Lane, both sides, from its junction with High Street westwards to its junction with Water Lane.

Water Lane, both sides, from its junction with High Street northwards for a distance of 16 metres.

SCHEDULE 2

Lengths of roads in High Street, Berkhamsted

Waiting limited to 1 hour, no return within 2 hours, 8.30 a.m. to 6.30 p.m. Mondays to Saturdays inclusive

High Street, north-east side, marked parking bays:

- (1) From a point 22 metres south-east of the centre line of Water Lane south-eastwards for a distance of 22 metres.
- (2) From a point 31 metres north-west of the centre line of Church Lane south-eastwards for a distance of 16 metres.
- (3) From a point 3 metres north-west of the centre line of Rectory Lane south-eastwards for a distance of 16 metres.
- (4) From a point 23 metres south-east of the centre line of Rectory Lane south-eastwards for a distance of 11 metres.

High Street, south-west side, marked parking bays:

- (1) From a point 42 metres south-east of the centre line of Kings Road south-eastwards for a distance of 32 metres.
- (2) From a point 21 metres north-west of the centre line of Chesham Road south-eastwards for a distance of 14 metres.
- (3) From a point 7 metres south-east of the centre line of Chesham Road south-eastwards for a distance of 24 metres.
- (4) From a point 39 metres north-west of the centre line of Rectory Lane south-eastwards for a distance of 16 metres.
- (5) From a point 15 metres south-east of the centre line of Rectory Lane south-eastwards for a distance of 11 metres.

SCHEDULE 3

Lengths of road in High Street, Berkhamsted

No waiting at any time other than by authorised disabled persons

High Street, north-east side, marked parking bays:

- (1) From a point 42 metres south-east of the centre line of Lower Kings Road south-eastwards for a distance of 8 metres.
- (2) From a point 53 metres north-west of the centre line of Water Lane south-eastwards for a distance of 23 metres.
- (3) From a point 35 metres south-east of the centre line of Church Lane south-eastwards for a distance of 17 metres.
