(iv) to prohibit driving at any time except for access for loading/unloading on:

St. Mary's Gate, south side, from 35-5 metres east of Deansgate for 32 metres east.

Market Street, south side, from 10 metres west of Corporation Street for 22 metres west.

St. Ann Street, north side, from 23 metres west of Cross Street for 32 metres west and from 35 metres east of Deansgate for 41 metres east.

This Order is intended to complement the pedestrianisation of St. Ann's Square and that the Order will be reinforced by a system of automatic retractable bollards or similar appropriate barriers to be located at the south end of Barton Square and the north end of Exchange Street. Arrangements are to be made to provide for access by emergency services and statutory undertakers, and for vehicles being used for the maintenance of shop premises on St. Anns Square.

(B) Parking Places and Controlled Parking Zone (Manchester) Order 1971 (Variation) No. 126 Order 1994.

- (i) to remove the ½ hour parking bays on:
  (a) St. Mary's Gate, on the north side, at a point 19 metres east of Deansgate for 45 metres east (13 meters to be removed) and on the south side at a point 15 metres east of Deansgate for 35 metres east (4 meters to be removed)
  - (b) Market Street, on the north side, at a point 26.2 metres west of Corporation Street for 39.8 metres west (12 meters to be removed); and on the south side from 10 metres east of Exchange Street for 35 metres east (12 meters to be removed).

(ii) to prohibit waiting at any time on:

St. Ann Street, both sides from Deansgate to Cross Street (except as privided in A(i) above.

(iii) to prohibit loading/unloading at any time on:

- St. Ann Street, north side, from Deansgate for 35 metres east; from 76 metres east of Deansgate for 35 metres east; from Cross Street for 23 metres west.
- St. Ann Street, south side, from Deansgate for 36 metres east; from 77 metres east of Deansgate for 35 metres east; from Cross Street for 11 metres west.
- (iv) to introduce one-way traffic working on St. Ann Street from Deansgate towards Cross Street.
- (C) City of Manchester (St. Mary's Gate, Manchester) (Revocation of Prohibition of Left Turn) (Experimental) Order 1994.

To revoke the existing ban on the left turn for vehicles from St. Mary's Gate into Deansgate. The Order is to be made on an experimental basis to last up to 18 months to allow for its effects to be monitored.

(D) City of Manchester (Various Streets, Manchester City Council) (Disabled Person's Parking Places) (Amendment) Order 1994.

To establish parking bays for the use of orange badge holders on:

Market Street, layby on the north side, from 26.6 metres west of Corporation Street for 39-8 metres west.
