#### *Royal County of Berkshire (York Way Area, Sandhurst) (20 m.p.h. Speed Limit) Order 1994*

### BURY METROPOLITAN BOROUGH COUNCIL

#### *The Metropolitan Borough of Bury (Queens Drive, Prestwich) (Prohibition of Waiting) Order 1994*
