

2. north side, from a point 142 metres east of its junction with Maryfield Avenue eastwards for a distance of 16 metres;

3. south side, from its junction with Culverland Road eastwards for an additional 4 metres and westwards for an additional 17 metres;

4. south side, from its junction with Culverland Close eastwards and westwards for 32 metres.

*Maryfield Avenue*, both sides, from its junction with Union Road northwards for a distance of 12 metres.

*Culverland Close*, both sides, from its junction with Union Road southwards for a distance of 12 metres.

The proposed Order will contain the usual exemptions relating to the picking up and setting down of passengers, loading and unloading of goods, disabled person's vehicles, the maintenance of the road and telecommunications apparatus, the supply of gas, water and electricity, and the existing waiting restrictions for Union Road, Exeter.

#### DYFED COUNTY COUNCIL

*The County of Dyfed (St. James' Street, Narberth) (Prohibition of Waiting) (Amendment) Order 1994*

Notice is hereby given that on 14th November 1994, the Dyfed County Council made an Order under sections 1(1) and (2), 2(1) to (3) and 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act").

The effect of this Order is to revoke:

(1) The County of Pembroke (Various Streets, Narberth) (Prohibition and Restriction of Waiting) Order 1972, insofar as it relates to the north side of St. James Street, Narberth, from a point approximately 32 metres south-west of its junction with Spring Gardens south-westwards to a point approximately 9 metres north-east of its junction with Tabernacle Lane.

(2) The County of Dyfed (St. James' Street, Narberth) (Experimental Prohibition and Restriction of Waiting (Revocation) Order 1993).

The Order will come into operation on 5th December 1994, and a copy of the Order, together with a map indicating the sides of road affected, may be inspected at the offices of the Dyfed County Council at County Hall, Carmarthen, during normal office hours.

Any person who desires to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Act or on the grounds that any requirement of the Act, or of any Instrument made under it has not been complied with in relation to the Order, may, within 6 weeks of the date on which the Order was made, apply to the High Court for this purpose.

*Street Parking in Essex Road and Rayleigh Road, Basingstoke*

Notice is hereby given that, Hampshire County Council proposes making a Parking Place Order as follows:

*Effect of Order:* To implement the following street parking arrangements in Essex Road and Rayleigh Road, Basingstoke, in place of those which currently apply:

(a) *Street Parking Places, unlimited waiting for permit holders only*

(i) East side of Essex Road for a length of 78 metres.

(ii) West side of Essex Road for a length of 30.4 metres.

(iii) East side of Rayleigh Road for 7 separate lengths totalling 83.7 metres.

(iv) West side of Rayleigh Road for 5 separate lengths totalling 100.9 metres.

(b) *Street Parking Places, waiting limited to 30 minutes, return prohibited within 1 hour, 9 a.m. to 5 p.m., all days permit holders exempt from time limit.*

West side of Essex Road, north of Southend Road, for a length of 71.4 metres.

(c) *No waiting at any time*

(i) West side of Essex Road for a length of 28 metres adjacent to its junction with Worting Road.

(ii) East side of Rayleigh Road for 2 separate lengths totalling 18 metres, adjacent to road junctions.

(iii) West side of Rayleigh Road for 4 separate lengths totalling 31.6 metres, adjacent to road junctions.

(d) *No waiting, 8 a.m. to 7 p.m. Monday to Saturday*

(i) East side of Essex Road for 3 separate lengths totalling 206.5 metres.

(ii) West side of Essex Road for 3 separate lengths totalling 144.7 metres.

(e) The usual exemptions will be included for loading/unloading and disabled drivers parking in respect of waiting restrictions specified in (c) and (d) above.

(f) *Permits*

A Residents Parking Permit (for parking without time limit in any parking space in the lengths specified under (a) and (b) above) may be available to any resident of Essex Road, Rayleigh Road or Worting Road property numbers 4-58 (even numbers) or 5-9 (odd numbers) on payment of £22 per annum. In addition, one-day visitors permits will be available to any of those residents free of charge. The Residents' Parking Scheme will be administered by, and permits will be issued by, Basingstoke and Deane Borough Council.
