

Any person wishing to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Act or on the grounds that any requirement of the Act or of any Instrument made under it has not been complied with in relation to the Order may within 6 weeks from the date of the Order apply to the High Court for this purpose.

NOTE: This Order replaces the Surrey County Council Mill Lane, Godalming (Weight Restriction) Order 1994 which was not inserted in *The London Gazette* and is therefore invalid.

##### *The East Sussex (A22/A295 Hailsham) (Derestriction) Order 1994*

Notice is hereby given that East Sussex County Council propose to make an Order under sections 82(2) and 83(2) of the Road Traffic Regulation Act 1984, as amended.

The Derestriction Order is proposed as the system of street lighting would otherwise impose a 30 m.p.h. speed limit along the lit lengths, which would be inappropriate on a road of this nature.

##### *Derestriction*

*A22 Hailsham*, from a point 93 metres north of the centre of the A295/A22 roundabout, to a point 92 metres south of the centre of the A295/A22 roundabout.

*A295 Hailsham*, from the centre of the A22/A295 roundabout, eastwards for a distance of 63 metres.

##### *The East Sussex (UC5068 and A275 Cooksbridge) (30 m.p.h. and 40 m.p.h. Speed Limits) Order 1994*

Notice is hereby given that East Sussex County Council propose to make an Order under sections 82(2), 83(2), 84(1) and (2) of the Road Traffic Regulation Act 1984, as amended, which will create speed limits of 30 m.p.h and 40 m.p.h. along the following length of road.

##### *30 m.p.h. Speed Limit*

##### *UC5068 Cooksbridge*

*Chandlers Mead*, for its entire length.

*Little Mead*, for its entire length.

##### *40 m.p.h. Speed Limit*

*A275 Cooksbridge*, from 40 metres south-west of the property known as "The Malthouse" (Village Hall), north-eastwards to 35 metres north-east of its junction with the UC5012.

This means that no person shall be able to drive any motor vehicle at a speed exceeding 30 m.p.h. or 40 m.p.h. along the lengths of road specified above. An exemption is included in the Order for any vehicle being used for Fire Brigade, Ambulance or Police purposes.

##### *The East Sussex (C208 Horebeech Lane and Vines Cross Road, Horam) (30 m.p.h. Speed Limit) Order 1994*
