The East Sussex (Restriction of Waiting and Loading in Brighton) (Consolidation) Order 1994 Amendment Order 1994 No. 3

Notice is hereby given that East Sussex County Council propose to make an Order under section 1(1) and (2), 2(1) to (3) and 4(2) of, and Parts III and IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, which if implemented will introduce a package of new and revised waiting restrictions along the following lengths of road:

Prohibition of Waiting on Mondays to Saturdays 6 p.m. to midnight, and midnight to 9 a.m.

Bond Street—west side for its entire length; east side: from North Street, northwards for 98 metres, and from 120 metres north of North Street, northwards to Church Street.

Bond Street Row—north side from 40.5 metres east of King Place, eastwards for 11.5 metres, and from 57.5 metres east of King

Place, eastwards for 3.5 metres.

Church Street—north side from a point 17.5 metres west of the western kerb-line of Gardner Street, to a point 19 metres east of a prolongation of the western kerb-line of New Road.

Jew Street—both sides for its entire length (except for the east side between a point 1.5 metres north of Bond Street Laine, and a point 5.5 metres northwards thereof.

Prohibition of Loading on Mondays to Saturdays 9 a.m. to 6 p.m.

North Street—north side from Bond Street, westwards for 4 metres, and from 15 metres west of Bond Street, westwards for 44 metres.

Prohibition of Loading and Unloading "At Any Time"

Bond Street—west side for its entire length; east side: from north Street, northwards for 41 metres, from 80 metres north of North Street, northwards for 18 metres, and from a point 120 metres north of North Street, northwards to the southern kerb-line of Church Street.

A copy of the draft Order and plans showing the lengths of roads affected together with a statement of the County Council's reasons for proposing to make the Order and those parts of old Orders that are being revoked, may be examined at these offices between 9 a.m. and 4 p.m. inclusive, at Brighton Central Library, Church Street and at Brighton Borough Council's Town Hall main Reception area until 23rd December 1994.

The West Sussex County Council (Horsham: Various Roads) (Prohibition and Restriction of Waiting) (and Consolidation) Order 1994.

Manor Road:

(a) On both sides from a point 15 metres south-west of its junction with Wellington Road, south-westwards and westwards to a point 20 metres east of its junction with Henley Road.

(b) On both sides from a point 30 metres north-west from its junction with Parkfield Road, north-westwards for a distance of 20 metres.

Osborne Grove, on both sides from the existing No Waiting at Any Time restrictions 15 metres south-eastwards of its junction with Parkfield Road south-eastwards for its entire length.

Parkfield Road, on the western side from the existing No Waiting at Any Time restrictions fronting No. 10, south as far as the northern edge of the layby fronting Parkfield County Primary School.
