

Sudcroft Street, Cardiff, on both sides from a point 10 metres south-west of its junction with Broad Street south-west to its cul-de-sac end.

Broad Street, Cardiff, on its south-west side from a point 15 metres north-west of its junction with Broadhaven to a point 17 metres south-east of its junction with Broadacres and from a point 15 metres north-west of its junction with Broadacres to a point 15 metres south-west of its junction with Fitzalan High School access road and from a point 15 metres north-west of the same junction for a distance of 30 metres north-west; and on its north-east side from a point 68 metres south-east of its junction with Broad Place for a distance of 36 metres north-west and from a point 26 metres south-east of its junction with Broad Place for a distance of 16 metres north-west and from a point 10 metres north-west of its junction with Broad Place to a point 16 metres south-east of the junction with Fitzalan High School access road and from a point 16 metres north-west of the junction with Fitzalan High School access road for a distance of 24 metres north-west.

Vigil Street, Cardiff, on its north-west side from a point 64 metres north-east of its junction with Sloper Road for a distance of 197 metres north-east.

4. Nature of restriction and lengths of road affected:

Prohibition of driving except for access to properties in the following roads or roads only accessible from the following roads:

- (a) Powderham Drive, Cardiff.
- (b) Langham Way, Cardiff.
- (c) Faber Way, Cardiff.
- (d) Wynstay Close, Cardiff.

5. Nature of restriction and lengths of road affected:

A. 50 m.p.h. speed restriction in:

- (a) *A4232 Butetown Link Road*, between a point 80 metres west of the western portals of the Queensgate Tunnel and the on and off slip roads leading to and from the Queensgate roundabout a distance of approximately 1,000 metres;
- (b) on and off slip roads to and from the Queensgate roundabout to the Butetown Link Road throughout their lengths.

B. 70 m.p.h. speed restriction in:

- (a) *A4232 Butetown Link Road*, between the western on and off slip roads to the Grangetown Link Road at Ferry Road Interchange and a point 80 metres west of the western portals of the Queensgate Tunnel a distance of approximately 1,650 metres;
- (b) the eastern on and off slip roads leading to and from the Ferry Road Interchange to the Butetown Link Road throughout their lengths;
- (c) the on and off slip roads leading to and from the Dudley Street/Stuart Street roundabout from the Butetown Link Road throughout their lengths.

No waiting at any time and no footpassengers in:

- (a) *Butetown Link Road (A4232)*, Cardiff, from the western on and off slip roads to the Grangetown Link Road situated at the Ferry Road Interchange to the on and off slip roads to the roundabout situated at Queensgate (a distance of approximately 2,640 metres);
- (b) the eastern on and off slip roads to and from the Ferry Road Interchange to the Butetown Link Road throughout their lengths;
- (c) the on and off slip roads leading to and from the Dudley Street/Stuart Street roundabout from the Butetown Link Road throughout their lengths.

7. Nature of restriction and lengths of road affected:

Prohibition of driving and pedal cycles or horse drawn vehicles in:

- (a) the *A4232 Butetown Link Road* between the western on and off slip roads to the Grangetown Link Road at the Ferry Road Interchange, to the on and off slip roads to and from the Queensgate roundabout, a distance of approximately 2,640 metres;
- (b) the eastern on and off slip roads to and from the Ferry Road Interchange to the Butetown Link Road throughout their lengths;
- (c) the on and off slip roads leading to and from the Dudley Street/Stuart Street roundabout from the Butetown Link Road, throughout their lengths;
- (d) the on and off slip roads to and from the Queensgate roundabout to the Butetown Link Road, throughout their lengths.
