## TRANSPORT AND WORKS ACT 1992

### Piccadilly Line (Heathrow T5 Extension) Order

Notice is hereby given that application is being made by London Underground Limited and Heathrow Airport Limited to the Secretary of State for Transport, 2 Marsham Street, London SW1P 3EB, for an Order under section 1 of the Transport and Works Act 1992 for purposes of which the following is a concise summary:
