

The Order shall be operative from 6th December 1994 and a copy thereof and a map showing the sides of lengths of road to which the Order relates together with a statement of reasons for the County Council making the Order may be inspected at the offices of the Mid Glamorgan County Council, Cathays Park, Cardiff during normal office hours.

The Mid Glamorgan County Council shall be considering in due course whether the provisions of the Order shall continue in force indefinitely. Objections to the proposal, together with the grounds on which they are made must be sent in writing to the undersigned within 3 months from 6th December 1994.

The County Secretary and Solicitor may provide for the suspension or modification of the Order or part thereof, while it is in force if it appears that it is essential in the interests of the expeditious, convenient and safe movement of traffic, or of the provision of suitable and adequate parking facilities on the highway, or for preserving or improving the amenities of the area through which any road affected by the Order runs.

Any persons wishing to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order, may within 6 weeks from 6th December apply to the High Court for this purpose.

Sides of Lengths of Road in the Borough of Taff Ely

1. The western side of Taff Street, Pontypridd from a point 15 metres (16 yards) south-west of its junction with Bridge Street south-westwards to a point 35 metres north-east of its junction with Crossbrook Street, a distance of approximately 63 metres (69 yards).
2. The eastern side of Taff Street, Pontypridd:
 - (a) From a point 15 metres (16 yards) south of the unnamed road leading to the Precinct car park, to a point 10 metres (11 yards) north of its junction with Temperance Place a distance of approximately 111 metres (122 yards).
 - (b) From a point 10 metres (11 yards) south of its junction with Temperance Place southwards a distance of approximately 150 metres (164 yards).

Side of lengths of road in the Borough of Taff Ely

1. The western side of Taff Street, Pontypridd:
 - (a) From the southern side of its junction with Mill Street, south-westwards for a distance of 15 metres (16 yards).
 - (b) From its southern junction with Market Street to a point opposite the common boundary of Nos. 63 and 64 Taff Street, a distance of approximately 200 metres (220 yards).
 - (c) From a point 15 metres south-west of its junction with Crossbrook Street northwards to a point 15 metres north-east of that junction, a distance of approximately 35 metres (38 yards).
 - (d) From its junction with Bridge Street south-westwards for a distance of 15 metres (16 yards).
 - (e) From the north-eastern side of its junction with Mill Street, north-eastwards for a distance of 15 metres (16 yards).
 - (f) From a point 15 metres (16 yards) south-west of its junction with Crossbrook Street south-westwards for a distance of 80 metres (88 yards).
2. The eastern side of Taff Street, Pontypridd:
 - (a) From a point 15 metres (16 yards) south-west of its junction with the unnamed road leading to the Precinct car park, to a point 15 metres (16 yards) north-east of that junction, a distance of approximately 39 metres (42 yards).
 - (b) From its junction with Bridge Street south-westwards for a distance of 17 metres (19 yards).
 - (c) From a point 10 metres (11 yards) south of its junction with Temperance Place northwards to a point 10 metres north of that junction a distance of approximately 28 metres (30 yards).
