#### TOWN AND COUNTRY PLANNING ACT 1990

*The Stopping-up of Highways (Lay-by, St. Mellons Road, North Pentwyn, Cardiff, South Glamorgan) Order 199*

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 247 of the Town and Country Planning Act 1990 to authorise the stopping-up of the highway described in the Schedule to this notice.

If the Order is made, the stopping-up will be authorised only in order to enable landscaping to be carried out in accordance with planning permission granted to Surveying and Management Consultancy by Cardiff City Council on 25th July 1994 under reference 94/722N.

During the 28 days from 1st December 1994 copies of the draft Order and the annexed plan may be inspected during normal opening hours (10 a.m. to 1 p.m., 2 p.m. to 6 p.m. Mondays to Thursdays, 10 a.m. to 1 p.m., 2 p.m. to 7 p.m. Fridays and 9 a.m. to 1 p.m., 2 p.m. to 5.30 p.m. Saturdays) at Llanedeyrn Library, Maelfa Shopping Centre, Llanedeyrn, Cardiff.

Within the above-mentioned period of 28 days any person may, by notice to the Welsh Office, Highways Directorate, Roads Administration Division, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL (quoting Ref. ZC 510-5-7-32), object to the making of the Order. In the preparation of an objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

#### SCHEDULE

*(All measurements are approximate)*

The highway to be stopped up is at Cardiff in the county of South Glamorgan. It is shown by zebra hatching on the annexed plan and is the lay-by lying on the southern side of St. Mellons Road which extends from a point 92 metres west of the junction of St. Mellons Road with Bridge Road in a westerly direction for a distance of 30 metres, having a maximum width of 7 metres.
