GLOUCESTERSHIRE COUNTRY COUNCIL

Gloucestershire County Council (Walkley Hill, Rodborough, Stroud) (Prohibition of Waiting Restrictions) Order 1995

Notice is hereby given that on 24th January 1995 the Gloucestershire County Council made an Order under the Road Traffic Regulation Act 1984, the effect of which is to prohibit any vehicle from waiting at any time in parts of the following roads:

Walkley Hill (3/267) and Church Place (47523).

The Order will contain the usual exemptions to permit waiting for the purposes of boarding and alighting, loading and unloading, building operations or work on or under the road and in connection with the services as statutory undertakers. Exemptions will also apply to disabled person's vehicle.

A copy of the Order which comes into effect on 8th February 1995 together with the relevant plan may be inspected during normal office hours at the offices of Gloucestershire County Council, Shire Hall, Westgate Street, Gloucestershire and the County Library, Lansdowne, Stroud, Gloucestershire during normal opening times.

Any person wishing to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any Instrument made under it has not been complied with in relation to the Order, may within 6 weeks of the date on which the Order is made, apply to the High Court for this purpose.

HAMPSHIRE COUNTY COUNCIL

Road Humps in Green Lane, Clanfield

Notice is hereby given that Hampshire County Council, propose introducing a traffic calming scheme as follows:

Effect of scheme: The provision of a system of 7 road humps in Green Lane, Clanfield, road humps will be of the flat top type extending from kerb to kerb, 60 millimetres in height and 6 metres in length, to be constructed at the following locations in Green Lane:

- (i) From a point 151 metres south of the centre-line of Redwing Road, southwards for a distance of 6 metres (i.e., adjacent to property No. 1).
- (ii) From a point 83 metres south of the centre-line of Redwing Road, southwards for a distance of 6 metres (i.e., adjacent to property No. 11).
- (iii) From a point 23 metres south of the centre-line of Redwing Road, southwards for a distance of 6 metres i.e., adjacent to property No. 19).
- (iv) From a point 35 metres north of the centre-line of Redwing Road, northwards for a distance of 6 metres (i.e., adjacent to property No. 29).
- (v) From a point 21 metres south of the centre-line of St. James Close, southwards for a distance of 6 metres (i.e., adjacent to property No. 37).
- (vi) From a point 19 metres north of the centre-line of St. James Close, northwards for a distance of 6 metres (i.e., adjacent to property No. 43).
- (vii) From a point 67 metres north of the centre-line of St. James Close, northwards for a distance of 6 metres (i.e., adjacent to property No. 49).

HEREFORD AND WORCESTER COUNTY COUNCIL

The County of Hereford and Worcester (Egg Hill Industrial Estate, Droitwich) (Prohibition of Waiting) (No. 1) and (No. 2) Orders 1995.
