

## HERTFORDSHIRE COUNTY COUNCIL

*The Hertfordshire (Various Roads, Dane End, Little Munden) (30 m.p.h. and 40 m.p.h. Speed Limits) Orders 1995*

Notice is hereby given that the Hertfordshire County Council propose to make Orders under sections 81, 82(2), 83(2) and 84 of the Road Traffic Regulation Act 1984, the effect of which will be to:

- (a) introduce 30 m.p.h. speed restrictions on roads in Dane End, Little Munden as specified in Schedule 1 below;
- (b) introduce 40 m.p.h. speed restrictions on roads in Dane End, Little Munden as specified in Schedule 2 below.

A copy of the draft Orders, together with a map showing the lengths of roads concerned and a statement of reasons for proposing to make the Orders may be inspected at the offices of Ware Town Council, The Priory, High Street, Ware, and at Hertfordshire County Council, at Room 223A, County Hall, Hertford, during normal office hours. ## SCHEDULE 1

*Lengths of Roads at Dane End to be subject to a 30 m.p.h. Speed Limit*

- U35 Church Lane*, from its junction with C16 Munden Road north-westwards for a distance of 492 metres.
- U114 Easington Road*, the whole length from its junction with Munden Road.
- U88 Kingsfield Road*, the whole length from its junction with Easington Road to its junction with Fouceley Avenue.
- U1072 Whiteley Close*, the whole length from its junction with Kingsfield Road.
- U1073 Windmills*, the whole length from its junction with Kingsfield Road.
- U203 Fouceley Avenue*, the whole length from its junction with Church Lane to its junction with Gladstone Road.
- U204 Gladstone Road*, the whole length from its junction with Church Road to its junction with Fouceley Avenue.
- U44 Windy Rise*, the whole length from its junction with Munden Road to its junction with Fouceley Avenue.
- U202 Paget Cottages*, the whole length from its junction with Windy Rise.
- U46 Kennedy Road*, the whole length from its junction with Easington Road.
- U118 Pearman Drive*, the whole length from its junction with Munden Road.

## SCHEDULE 2

*Lengths of Roads at Dane End, Little Munden to be subject to a 40 m.p.h. Speed Limit*

- C16 Munden Road*, from a point 20 metres north-east of its junction with Church Lane south-westwards for a distance of 900 metres.
- Un-named Road C39*, from its junction with Munden Road westwards for a distance of 125 metres.

*The Hertfordshire (South Street, Potter Street and Market Street, Bishop's Stortford) (20 m.p.h. Speed Limit) Order 1994*

*Lengths of roads in Benington—Proposed 30 m.p.h. Speed Limit*

- C31 Walkern Road/Town Lane*, from a point 111 metres west of the centre-line of the access to Box Hall in Walkern Road southwards and eastwards, for a distance of 1,482 metres.
- Old School Lane*, from its junction with Alkern Road north-eastwards, for a distance of 291 metres.
- U33 Duck Lane*, from its junction with Walkern Road north-eastwards, for a distance of 516 metres.
- C29 Aston Road*, from both arms of the junction with Walkern Road and Town Lane at Church Green south-westwards for a distance of 270 metres.
- Three Stiles*, from its junction with Town Lane northwards and eastwards to its junction with Blacksmiths Hill.
- Blacksmiths Hill*, the entire length from its junction with Three Stiles.

## SCHEDULE 2

*Lengths of roads in Benington—Proposed 40 m.p.h. Speed Limit*

- C31 Whempstead Road*, from a point 2 metres south of the northern boundary of 68 Whempstead Road northwards, for a distance of 997 metres to the termination of the proposed 30 m.p.h. speed limit in Town Lane detailed in Schedule 1 above.
- Hebing End*, the entire length from its junction with Whempstead Road.
- Burns Green Road*, the entire length from its junction with Whempstead Road.
- Goodey Meade*, the entire length from its junction with Whempstead Road.
