Prohibition of waiting at any time in lengths of road at South Shields in the Borough of South Tyneside

Hudson Street (East), west side, from the southern kerb of Whitehead Street, in a northerly direction for the remainder of its length including the cul de sac head.

Notice is hereby given that the Wirral Borough Council in exercise of its powers have made the following Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984.

The effect of the Order will be to prohibit the waiting of vehicles at the times and in the lengths and sides of roads specified in the Schedule.

Exceptions will be provided in the Order to permit picking-up and setting down of passengers, loading and unloading of goods, maintenance of roads, supply of gas, electricity and water, in pursuance of statutory powers and duties, disabled person's parking and hackney carriages to wait upon authorised ranks.

The Order will come into operation on 1st February 1995, and copies thereof may be seen at all reasonable hours at the Borough Solicitor and Secretary's Department, Town Hall, Wallasey.

Lengths of Road in Birkenhead

- Cleveland Street**, both sides, from the eastern-most side of its junction with Watson Street/Rendel Street, for a distance of 50 metres in a south-easterly direction.
- Cleveland Street**, north side, from the western-most side of its junction with Rendel Street, for a distance of 36 metres in a north-westerly direction.
- Cleveland Street**, south side, from the western-most side of its junction with Watson Street for a distance of 11 metres in a north-westerly direction.
- Watson Street**, both sides, from a point 50 metres south of its junction with Cleveland Street.

- Brook Street**, both sides, from its junction with Watson Street, for a distance of 10 metres in a westerly direction.
- Rendel Street**, both sides, for its whole length.
- Marcus Street**, both sides, from the southern-most side of its junction with Rendel Street, for a distance of 45 metres in a southerly direction.
- Corporation Road**, both sides, from its junction with Tower Road, for a distance of 150 metres.
- Freeman Street**, east side, from its junction with Corporation Road, for a distance of 30 metres in a southerly direction.
