- (1) To provide a Bus Lane on parts of the A610 Alfreton Road (Inbound to the City between Gregory Boulevard and Canning Circus) during the morning peak period on Mondays to Fridays inclusive;
- (2) To impose peak period No Right Turns from Alfreton Road into both Boden Street and Highurst Street;
- (3) To incorporate certain existing restrictions.

The usual exemptions will be provided. Relevant documents may be inspected at my office or at the office of the Secretary and Solicitor, Nottingham City Counil, The Guildhall, Nottingham. Any person wishing to question the validity of the Order (which was made on 20th January 1995), of any of the provisions contained in it on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any Instrument made under it, has not been complied with in relation to the Order may, within 6 weeks from 20th January 1995, apply to the High Court for this purpose

Written objections to the making of a permanent Order stating grounds and quoting (ref. 6065) must be received by me within 6 months of the coming into force of (1) the experimental Order or (2) any relevant variation or modification Order to the experimental Order.

The experimental Order will come into force on 13th February 1995, and continue untill 12th August 1996, inclusive.
