The A487 Trunk Road (North Road, Caernarfon, Gwynedd)
(Prohibition of Waiting) Order 199

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to prohibit waiting at any time (with certain exceptions) on the length of the A487 Fishguard-Bangor Trunk Road (hereinafter referred to as "the trunk road") described in the Schedule to this notice.

Copies of the proposed Order, relevant plan and statement of reasons for the making of the proposed Order may be inspected, free of charge, during normal office hours at the offices of Gwynedd County Council, County Offices, Caernarfon, Gwynedd, during a period of 21 days from 3rd February 1995.

Objections, specifying the grounds on which they are made, and quoting reference ZC 510-2-4-91 must be sent in writing to the Welsh Office, Highways Directorate, Roads Administration Division, Phase, 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, by 24th February 1995. In the preparation of an objection and the statement of grounds of objection it should be borne in mind

that the substance of any objection of representation may be communicated to other people who may be affected by it.

SCHEDULE

That length of the trunk road, known as North Road, at Caernarfon in the County of Gwynedd, extending from, but not including, St. David's Road Roundabout in a north-easterly direction to a point 44 metres north-east of the centrepoint of its junction with Warfield Road. (481)

HIGHWAYS ACT 1980

The County of Dyfed (Tenby—Cardigan Principal Road A478)
(Proposed Replacement of Longford Bridge, Clynderwen) Side Roads Order 1994.

The Secretary of State for Wales hereby gives notice that he has confirmed the above Order which was made by the County Council of Dyfed under sections 14 and 125 of the Highways Act 1980 and which, as confirmed, authorises the Council:

- (a) to improve, raise, lower or otherwise alter highways,
- (b) to stop-up highways,
- (c) to construct new highways,
- (d) to stop-up private means of access to premises, and
- (e) to provide new means of access to premises.

Copies of the Order, as confirmed, and of the relevant plan may be inspected, free of charge, at all reasonable hours at the offices of the Dyfed County Council (County Secretary's Department, Room 61), County Hall, Carmarthen and at the Post Office, Clynderwen, Dyfed.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980, or on the ground that any requirement of that Act or of any regulation made thereunder has not been complied with may, within 6 weeks of 3rd February 1995, apply to the High Court for the suspension or quashing of the Order or any provision contained therein.
