## DEPARTMENT OF HEALTH

PERMITTED ADDITIVES TO TOBACCO PRODUCTS IN  
THE UNITED KINGDOM

The Department of Health is announcing the availability of a new list detailing the permitted additives to tobacco products in the United Kingdom. The list includes those additives to tobacco products (specifically cigarettes, cigarette papers, roll-your-own tobaccos, cigars and pipe tobacco) approved for use on products marketed in the United Kingdom which appeared in Appendix VII of the Second Report of the Independent Scientific Committee on Smoking and Health and in Appendix I of the Committee's Fourth Report, together with any additional permitted but previously unpublished additives.
