## EXETER CITY COUNCIL

### *The City of Exeter (Off-street Parking Places) Order 1991 (Amendment) (No. 9) Order 1995*

Notice is hereby given that the Exeter City Council proposes to make the above-mentioned Order under section 35 and Part IV of Schedule 9 and Schedule 10 to the Road Traffic Regulation Act 1984, and all other enabling powers.

The general nature and effect of the proposed Order is as follows in respect of the following car parks in the City of Exeter:

#### 1. All Car Parks

To issue a Standard Charge Notice to the registered keeper of any vehicle left in any of the City's car parks which is not displaying a valid road fund licence. The Standard Charge is the penalty charge payable by persons contravening the Order and is £30 unless paid within five working days from the date of contravention in which case the Standard Charge is £15.

#### 2. Cathedral and Quay Car Park

To introduce a residents' season ticket scheme at £50 per annum for residents who live within the vicinity of the Cathedral and Quay Car Park.

#### 3. Fairpark Car Park

To amend the pay and display charges for car parking at Fairpark Car Park during any charging period as follows:
