30 m.p.h. Speed Limit, Various Roads, Hillyfields/Nursling

Notice is hereby given that, Hampshire County Council proposes making a speed limit Order as follows:

Effect of Order: To impose a 30 m.p.h. speed limit in the following lengths of road at Hillyfields/Nursling:

- (i) That length of the C125 Redbridge Lane between its junction with the A3057 Romsey Road and a point 215 metres south-west thereof.
- (ii) That length of the C125 Redbridge Lane between a point 630 metres south-west of its junction with the A3057 Romsey Road and a point 370 metres south-west of that point.
- (iii) Jarretts Lane for its entire length, a distance of approximately 230 metres.
- (iv) Frogmore Lane (C227) for its entire length, a distance of approximately 300 metres.
- (v) Hillyfields for its entire length (including cul-de-sac), a combined distance of approximately 305 metres.
- (vi) Danebury Way for its entire length, a distance of approximately 70 metres.
- (vii) Toogoods Way for its entire length, a distance of approximately 140 metres.
- (viii) Yewtree Lane for its entire length, a distance of approximately 135 metres.

30 and 40 m.p.h. Speed Limits, Various Roads, The Wallops

Notice is hereby given that Hampshire County Council proposes to make a Speed Limit Order as follows:

Effect of Order: to impose 30 and 40 m.p.h. speed limits in the following lengths of road at the Wallops:

*Nether Wallop**30 m.p.h. Speed Limits*

- (i) *Heathman Street*, between its junction with The Causeway and a point 100 metres north of its junction with the C81, a distance of approximately 1,000 metres.
- (ii) *High Street*, for its entire length, a distance of approximately 300 metres.
- (iii) *Church Hill*, between its junction with High Street and a point 390 metres south-east thereof.
- (iv) *Five Bells Lane*, between its junction with The Causeway and a point 39 metres south-west of its junction with Aylwards Way, a distance of approximately 390 metres.
- (v) *Aylwards Way*, for its entire length, a distance of approximately 150 metres.
- (vi) *Hoskets Lane*, between its junction with The Causeway and a point 90 metres south-west of Ducks Lane, a distance of approximately 460 metres.
- (vii) *The Causeway*, for its entire length, a distance of approximately 100 metres.
- (viii) *Gerrard's Farm Road*, between its junction with Farley Street and a point 193 metres north-east thereof.
- (ix) *Church Lane*, for its entire length, a distance of approximately 160 metres.

*Middle Wallop**40 m.p.h. Speed Limit*

- (i) *A343* between a point 15 metres north-east of New Road and a point 1,030 metres north-east of that point.

30 m.p.h. Speed Limit

- (i) *Farley Street*, between its junction with the A343 and its junction with The Causeway.
- (ii) *Knockwood Lane*, for its entire length, a distance of approximately 470 metres.
- (iii) *School Lane*, for its entire length, a distance of approximately 430 metres.

*Over Wallop**30 m.p.h. Speed Limit*

- (i) *Salisbury Lane*, for its entire length, a distance of approximately 870 metres.
- (ii) *Station Road*, between its junction with the A343 and a point 191 metres north-west of its junction with Evans Close, a distance of approximately 1,530 metres.
- (iii) *Evans Close*, for its entire length, a distance of approximately 170 metres.
- (iv) *Pound Road*, for its entire length, a distance of approximately 500 metres.
- (v) *King Lane*, between its junction with Station Road and a point 80 metres north-east of its junction with Pound Road, a distance of approximately 380 metres.
- (vi) *Orange Lane*, for its entire length, a distance of approximately 150 metres.
- (vii) *Horshells Drove*, for its entire length, a distance of approximately 180 metres.
