The Trunk Roads (A470 and A4060) (Abercynon-Pentrebach, Mid Glamorgan) (De-restriction and (40 m.p.h. Speed Limit)) Order 1985 (Variation) Order 1995.

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 82, 83, 84 and 124 of the Road Traffic Regulation Act 1984. The effect of the proposed Order will be to extend the 40 m.p.h. speed limit on the A470 at Pentrebach Roundabout from its present position 46 metres south of the centrepoint of the roundabout for a distance of 316 metres southwards.

In the preparation of an objection and the statement of grounds of objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.
