Proposed Traffic Regulation Orders

Notice is hereby given that Sefton Metropolitan Borough Council propose to make the following Orders under the provisions of the Road Traffic Regulation Act 1984, the effect of which is described in the Schedule below.

Copies of the draft Orders, relevant maps and statements of the Council's reasons for proposing to make the Orders may be inspected at the offices of the Director of Technical Services, Balliol House, Stanley Precinct, Bootle, and the Director of Legal and Administrative Services, Town Hall, Lord Street, Southport, during normal office hours.

Objections to the proposals, together with the grounds on which they are made, must be sent in writing to the Director of Legal and Administrative Services, Town Hall, Lord Street, Southport PR8 1DA, by no later than 24th February 1995.

SCHEDULE

1. *Metropolitan Borough of Sefton (Sussex Road, Southport) (Prohibition of Waiting) Order 199*

- (a) To prohibit the waiting of vehicles at all times on both sides of Sussex Road from a point 20 metres south-east of the south-easterly kerb-line of Derby Road for a distance of 45 metres in a south-easterly direction; and
- (b) to prohibit the waiting of vehicles between 8 a.m. and 6 p.m., Monday to Saturday, on the north-east side of Sussex Road from a point 65 metres south-east of the south-easterly kerb-line of Derby Road to the junction of Hall Street.

2. *Metropolitan Borough of Sefton (Queens Road/Manchester Road/Hawkshead Street/Alexandra Road, Southport) (Prohibition of Waiting) Order 199*

To prohibit the waiting of vehicles at all times on the following lengths of roads:

Queens Road:

- (i) North-west side, from the north-east kerb-line of Walton Street for a distance of 150 metres in a north-easterly direction;
- (ii) Both sides, from a point 15 metres south-west of the south-west kerb-line of Alexandra Road to a point 15 metres north-east of the north-east kerb-line of Alexandra Road.

Manchester Road:

- (i) North-east side, from a point 15 metres from its junction with Queens Road for a distance of 130 metres in a south-easterly direction;
- (ii) South-west side, from a point 55 metres from its junction with Houghton Street for a distance of 10 metres in a south-easterly direction.

Hawkshead Street (both sides), from a point 13 metres south-east of the south-east kerb-line of Queens Road for a distance of 10 metres in a south-easterly direction.

Alexandra Road (both sides), from a point 15 metres south-east of the south-east kerb-line of Queens Road to a point 15 metres north-west of the north-west kerb-line of Queens Road.

3. *Metropolitan Borough of Sefton (St. James Street and Scarisbrick New Road, Southport) (Prohibition of Waiting) Order 199*

To prohibit the waiting of vehicles at all times on the following lengths of roads:

St. James Street:

- (a) North-west side, from the south-western kerb-line of Bridge Grove for a distance of 32 metres in a south-westerly direction;
- (b) South-east side (existing restrictions to be extended as follows): From a point 29 metres south-west of the south-west kerb-line of Southbank Road to a point 15 metres north-east of the north-easterly kerb-line of Southbank Road.

Scarisbrick New Road:

- (a) South-west side, from a point 12 metres south-west of the south-western kerb-line of Scarisbrick New Road for a distance of 20 metres in a south-easterly direction;
- (b) North-east side, from a point 103 metres north-west of the north-western kerb-line of Linaker Street for a distance of 22 metres in a north-westerly direction.

4. *Metropolitan Borough of Sefton (Westcliffe Road and Palatine Road, Southport) (Prohibition of Waiting) Order 199*

To prohibit the waiting of vehicles at all times on the following lengths of roads:

Westcliffe Road (south-east side), from a point 62 metres south-west of the junction of Lord Street West to a point 15 metres south-west of the south-western kerb-line of Palatine Road;

Palatine Road (both sides), from the south-eastern kerb-line of Westcliffe Road for a distance of 15 metres in a south-easterly direction.

5. *Metropolitan Borough of Sefton (Gordon Street/Leicester Street, Southport) (Prohibition of Waiting) Order 199*

To prohibit the waiting of vehicles at all times on the following lengths of roads:

Gordon Street (both sides), from the north-eastern kerb-line of Leicester Street for a distance of 15 metres in a north-easterly direction;

Leicester Street (both sides), from the north-western kerb-line of Gordon Street for a distance of 15 metres in a north-westerly direction.

6. *Metropolitan Borough of Sefton (Duke Street, Southport) (Prohibition of Waiting) Order 199*

To prohibit the waiting of vehicles at all times on the south-west side of Duke Street from the junction with Part Street to the junction with Railway Terrace.

7. *Metropolitan Borough of Sefton (Sandringham Road/Chatsworth Road/Knowle Avenue, Ainsdale) (Prohibition and Restriction of Waiting) Order 199*

(a) To prohibit the waiting of vehicles at all times on the following lengths of roads:

Sandringham Road

East side, from a point 20 metres south of the southerly kerb-line of Chatsworth Road for a distance of 162 metres in a northerly direction.

West side:

(a) from a point 20 metres south of the southerly kerb-line of Chatsworth Road to a point 15 metres north of the northerly kerb-line of Chatsworth Road;

(b) from a point 15 metres south of the southerly kerb-line of Knowle Avenue to a point 15 metres north of the northerly kerb-line of Knowle Avenue.

Chatsworth Road (both sides), from the westerly kerb-line of Sandringham Road for a distance of 15 metres in a westerly direction.

Knowle Avenue (both sides), from the westerly kerb-line of Sandringham Road for a distance of 20 metres in a westerly direction.

- (b) To introduce limited waiting of 1 hour in 2, 8 a.m. to 5 p.m., Monday to Friday, on the west side of Sandringham Road from the boundary of No. 39 Sandringham Road with the school premises for a distance of 30 metres in a southerly direction.

8. *Metropolitan Borough of Sefton (Musker Street/Endbutt Lane, Crosby) (Prohibition of Waiting) Order 199*

To prohibit the waiting of vehicles at all times on the following lengths of roads:

Endbutt Lane (north-east side), from a point 15 metres north-west of the north-western kerb-line of Musker Street in a south-easterly direction to a point 38 metres south-east of the south-eastern kerb-line of Musker Street.

Musker Street (both sides), from the north-eastern kerb-line of Endbutt Lane in a north-easterly direction for a distance of 15 metres.

9. *Metropolitan Borough of Sefton (Rosedale Avenue, Crosby) (Disabled Person's Parking Place) Order 199*

To designate a disabled person's parking place outside No. 26 Rosedale Avenue, Crosby.

10. *Metropolitan Borough of Sefton (Wadham Road, Bootle) (Disabled Person's Parking Place) Order 199*

To designate a disabled person's parking place outside No. 74 Wadham Road, Bootle.

11. *Metropolitan Borough of Sefton (Greenfield Lane, Litherland) (Disabled Person's Parking Place) Order 199*

To designate a disabled person's parking place outside No. 4 Greenfield Lane, Litherland. (820)
