Notice of application for a licence to abstract water

The Bridgnorth District Council (Off-street Parking Places) (Variation and Consolidation) Order 1995

Take notice that Tattersett Farms Ltd. of Wicken Farm Site, Tattersett, Norfolk, is applying to the National Rivers Authority for a licence to abstract water from the chalk strata at National Grid Reference TF 8392 3188 at Wicken Farm Site, Tattersett, in the district of North Norfolk. The proposal is to abstract water at the following rates: 34.25 cubic metres per hour, 733 cubic metres per day, 4,090 cubic metres (between April 1st and September 30th each year). The water will be used for spray irrigation. This application is to replace licence serial No. 7/34/11/G/435 which expires in September 1995.

Notice is hereby given that on 6th February 1995, the Bridgnorth District Council made the above Order in exercise of their powers under sections 32, 35, 45 and 122 of the Road Traffic Regulation Act 1984. The effects of the Order which comes into force on 1st April 1995 are as follows:

A copy of the application and any map, plans and any other documents submitted with it may be inspected, free of charge, at all reasonable hours at Wicken Farm Site, Tattersett, between 7th February 1995 and 7th March 1995.

Any person who wishes to make representations about the application should do so in writing to the National Rivers Authority, Anglian Region, Eastern Area, Cobham Road, Ipswich, Suffolk IP3 9JB.

(i) To incorporate the new public car parks at Dark Lane, Broseley, and New Road, Much Wenlock, and to specify the charges and times upon which these facilities may be used, thus enabling effective management and enforcement of these parking areas to take place.

(ii) To increase charges for car parking for residents only car parking places at Friar Street (West), Friar Street (East) and Railway Street from £6 per annum to £12 per annum or from £3 per 6 months to £6 per 6 months. In addition to this, the discount given for payment of parking fines paid within 7 days will be increased. Formerly a discount from an initial charge of £25 down to £5 would be given. Under the above Order the discount will be from an initial charge of £25 down to £15.

(iii) To consolidate and revoke the Bridgnorth District Council (Off Street Parking Places) Order 1984 and the Bridgnorth District Council (Off Street Parking Places) (Variation) Order 1992.
