Waiting prohibited at all times with exemptions

Horsemarket Road, south-west side from its junction with The Mount to the southern boundary line of No. 3 Horsemarket Road.

Horsemarket Road, south-east side from the southern boundary line of the back entrance to the Green Man Public House southwards for a distance of 50 metres.

Horsemarket Road, east side from its junction with Lower Spital Street to its junction with Cattle Market.

Upper Spital Street, south-east side from its junction with Cattle Market to its junction with Newgate.

Waiting prohibited between 9 a.m. and 6 p.m. Mondays, Tuesday and Friday only with exemptions

Cattle Market, north-east side from its junction with Victoria Road/Horsemarket Road to its junction with Upper Spital

Upper Spital Street, north-west side from its junction with Cattle Market to its junction with Lower Middlecave Road.

### NORTH DEVON DISTRICT COUNCIL

The North Devon (Off-street Parking Places) Order 199

Notice is hereby given pursuant to section 35 of the Road Traffic Regulation Act 1984 (as amended), and of all enabling powers that, on 31st January 1995, the North Devon District Council made the above-mentioned Order which comes into force on 15th March 1995. The effect of this Order is to make provision as to the use, the charges and the conditions affecting off-street parking spaces in the area.

A copy of the Order together with maps showing the location of parking places can be seen at the Legal Services Unit Offices, Room 31, Civic Centre, Barnstaple, North Devon during normal office hours. Details of the parking places within the Order, time limits, charges and classes of vehicle in respect of the various parking places are detailed below.

Notice of proposals for this Order were published in The London Gazette numbered 53851 on 17th November 1994.

# SCHEDULE

In this Schedule:

- 1. The following combinations of vehicles shall be the Classes of vehicles permitted to park in the parking places:
  - 'V1' means solo motorcycles, registered disabled vehicles, motor cars and motorcycle combinations.
  - 'V2' means solo motorcycles, registered disabled vehicles, motor cars not exceeding 30 cwt unladen weight.
  - 'V3' means solo motorcycles, registered disabled vehicles, motor cars, motorcycle combinations and motor vehicles not exceeding 30 cwt unladen weight.
  - 'V4' means solo motorcycles, registered disabled vehicles, motor cars, motorcycle combinations, motor vehicles not exceeding 30 cwt unladen weight and trailers and caravans.
  - 'V5' means motor vehicles exceeding 30 cwt unladen weight.
  - 'V6' means coaches.
  - 'V7' means Hackney Carriages.
  - 'V8' means registered disabled vehicles, motor cars, motorcycle combinations and motor vehicles not exceeding 30 cwt unladen weight.
  - 'V9' means registered disabled vehicles, motor cars and motorcycle combinations.
  - 'V10' means solo motorcycles, registered disabled vehicles and motor cars.
  - 'V11' means parking for general public prohibited.
  - 'V12' means parking for general public prohibited except for those with reserved tickets.
    'V13' means parking for general public prohibited except for those with season tickets.
- 2. The scale of charges for each parking place shall be as follows:
- 'C1' means 30p per hour.
- 'C2' means 20p per hour, £1 per maximum 10 hours.
- 'C3' means between 15th March to 13th May and from 1st October to 31st October; up to 2 hours—30p; over 2 hours—50p and, from 14th May to 30th September—40p per hour.

  'C4' means from 14th May to 30th September—20p per hour £1 for
- max 12 hours.
- 'C5' means from 15th March to 31st October-£1 per hour, £6 for 12 hours.
- 'C6' means from 15th March to 31st October-40p per hour, 80p for up to 2 hours, £1.20 up to 3 hours, 3 hours or more £1.60.
- 'C7' means free of charge.
- 'C8' means 1st November to 14th March of the following year free of charge.
- 'C9' means 1st October to 13th May of the following year free of charge.

- 'C19' means £1 for first 2 hours and thereafter £1 per hour; maximum £8 all day for classes V5 and for V6.
- 'C20' means from 15th March to 31st October-40p per hour.
- 'C21' means 60p for 2 hours.
- 'C22' means from 1st May to 30th September between 9 a.m. and 9 p.m.—up to 2 hours—60p; over 2 hours up to 6 hours—£1.20; over 6 hours up to 12 hours—£1.80. From 1st May to 30th September between 9 p.m. and 9 a.m.—60p.
  For V5 vehicles from 1st May to 30th September—£1 per hour.
- 'C23' means reserved parking only-£75 per quarter; £275 per
- 'C24' means reserved parking available at Queen Street Multi-storey as follows:
- Ground floor—Quarterly—£85; Annual £325,
- Deck 7-Quarterly £55; Annual £195
- Deck 9—Quarterly £50; Annual £168.
