HIGHWAYS ACT 1980

The A483 Trunk Road (Derwydd, Llandybie, Dyfed) (De-Restriction) Order 199

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under section 82 and 83 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to de-restrict the length of road specified in the Schedule to this notice.

A copy of the proposed Order, together with a plan and statement of reasons for the making of the Order, may be seen at Llandybie Post Office, 27A High Street, Llandybie during normal opening hours (9 a.m. to 1 p.m., 2 p.m. to 5.30 p.m., Mondays, Tuesdays, Thursdays and Fridays, 9 a.m. to 1 p.m. on Wednesdays and 9 a.m. to 12.30 p.m., on Saturdays.

Objections specifying the grounds on which they are made, and quoting reference ZC510-6-2-71, must be sent in writing to the Welsh Office, Highways Directorate, Roads Administration Division, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, by 9th March 1995. In the preparation of an objection and the statement of grounds of objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.
