

## HEREFORD AND WORCESTER COUNTY COUNCIL

*The County of Hereford and Worcester (Villiers Street, Kidderminster) (Prohibition of Waiting) Order 1995*

Notice is hereby given that on 9th February 1995, Hereford and Worcester County Council made an Order which will:

- (a) prohibit waiting at any time on the north side of Villiers Street, Kidderminster from its junction with Lorne Street to a point 10 metres west of its junction with Chester Road North;
- (b) remove the double yellow lines on the south side of Villiers Street from a point 5 metres east of its junction with Lorne Street for a distance of 12 metres in an easterly direction.

The Order will come into operation of 22nd February 1995.

The Order contains exemptions to allow parking for certain purposes and limited waiting by disabled persons vehicles.

A copy of the Order, relevant map, statement of reasons for making the Order and affected existing regulations may be inspected at County Hall, Spetchley Road, Worcester WR5 2NP, during normal office hours.

## HEREFORD AND WORCESTER COUNTY COUNCIL

*The County of Hereford and Worcester (Green Street, Kidderminster) (Prohibition of Waiting) Order 1995*

Notice is hereby given that on 9th February 1995, Hereford and Worcester County Council made an Order which will prohibit waiting at any time on short lengths or Green Street, Kidderminster. The Order will come into operation on 22nd February 1995.

The Order contains exemptions to allow parking for certain purposes and limited waiting by disabled persons vehicles.

## HEREFORD AND WORCESTER COUNTY COUNCIL

*The County of Hereford and Worcester (Angel Place, Angel Street, Broad Street and Bank Street, Worcester) Various Orders 1995*

Notice is hereby given that Hereford and Worcester County Council are to consider making Orders which will:

1. Prohibit any vehicle from proceeding or waiting in:

- (a) Angel Place, from its junction with The Butts to its junction with Angel Street; and
- (b) Angel Street, from its junction with The Foregate to its junction with Angel Place.

Between the hours of 10.30 a.m. and 4.30 p.m., Monday to Saturday the following exemptions will apply to the following vehicles:

Emergency service vehicles, vehicles being used in any building or demolition operation, the removal of any obstruction to traffic, the maintenance of the road, and the supply and maintenance of any gas, electricity or telecommunications apparatus; Royal Mail liveried vehicles collecting from the Angel Mail post box; public service vehicles; taxis requiring access to the bus station taxi rank (this shall not apply to the length of road specified in (b) above); bullion vehicles; street trading vehicles authorised for use in Angel Place; vehicles requiring access to Angel Place between its junctions with Angel Street and Broad Street; pedestrian controlled electrically propelled vehicles.

Outside these hours the following exemptions shall also apply:

Vehicles being used in pursuance of statutory powers or duties; mechanical road cleansing vehicles; vehicles requiring access to land or premises fronting these length of roads; vehicles from which goods are being loaded and or unloaded; pedal cycles and tricycles; and invalid carriages.

- (c) Angel Place, from its junction with Angel Street to its junction with Broad Street;
- (d) Broad Street, from its junction with Angel Place to its junction with The Cross.

Between the hours of 10.30 a.m. and 4.30 p.m., Monday to Saturday, inclusive the following exemptions shall apply to the following vehicles;

Emergency service vehicles, vehicles being used in any building or demolition operation, the removal of any obstruction to traffic, the maintenance of the road, and the supply and maintenance of any gas, electricity and telecommunications apparatus; bullion vehicles; street trading vehicles authorised for use in Angel Place; vehicles using that length of Broad Street between its junctions with Angel Place and The Cross as a means of egress from Angel Place, and Broad Street between its junctions with Angel Place and Deansway; vehicles using that length of Angel Place between its junctions with Angel Street and Broad Street as a means of egress from Angel Place between its junction with The Butts and Angel Street, and Angel Street; and pedestrian controlled electrically propelled vehicles.

Outside these hours the following exemptions shall also apply:

Vehicles being used in pursuance of statutory powers or duties; mechanical road cleansing vehicles; vehicles requiring access to land or premises fronting these lengths of roads; Royal Mail liveried vehicles from which goods are being loaded and or unloaded; pedal cycles and tricycles; and invalid carriages.

2. Prohibit any heavy commercial vehicle, the maximum gross weight of which exceeds 7.5 tonnes, from proceeding on the entire length of Angel Place, Angel Street, Broad Street between the hours of 11 a.m and 6 p.m. on any day. This shall not apply to emergency service vehicles.

## HEREFORD AND WORCESTER COUNTY COUNCIL

## HERTSMERE BOROUGH COUNCIL

*The Hertsmere Borough Council (Dugdale Hill Lane/Sawyers Lane, Potters Bar) (One-way Traffic) Order 1995*
