The Borough of Reading Proposed Installation of Road Humps and Introduction of a 20 m.p.h. Speed Limit Zone in Reading Town Centre.

Notice is hereby given that on 6th December 1994 Reading Borough Council, pursuant to arrangements made under section 101 of the Local Government Act 1972 with the Berkshire County Council, decided to install road humps, as authorised by section 90(A) of the Highways Act 1980, in Oxford Road, St. Mary Butts and West Street in conjunction with the introduction of a 20 m.p.h. speed limit zone under section 84 of the Road Traffic Regulation Act 1984, to reduce the number of injury accidents.

It is proposed to install the road humps as follows:

(a) Oxford Road. 1 flat top hump 75 millimetres high between its junction with Cheapside and a point about 11 metres east of that junction.

(b) St. Mary Butts. 1 flat top hump 75 millimetres high between its junction with Hosier Street and a point about 11 metres north of

that junction.

(c) Oxford Road/West Street/St. Marys Butts. 75 millimetres high raised table junction hump. The hump will extend about 30 metres into Oxford Road, 16 metres into West Street and 22 metres into St. Marys Butts.

It is proposed to introduce the 20 m.p.h. speed limit zone as follows:

(a) West Street. The entire length.

(b) St. Marys Butts. Between its junctions with Hosier Street and Oxford Road.

(c) Oxford Road. Between its junctions with West Street and Cheapside.

The reason for introducing these road humps, in conjunction with the introduction of a 20 m.p.h. speed limit zone, is to reduce the number of injury accidents in this busy shopping area.

A plan showing exactly where the humps are to be installed and where the 20 m.p.h. speed limit will apply may be inspected at the Main Reception Desk, Civic Centre, Reading, from 9 a.m. to 5 p.m., Monday to Friday.
