Notice of application for consent in pursuance of Schedule 10

Notice is hereby given, in accordance with Schedule 10 of the Water Resources Act 1991, that an application has been made to the National Rivers Authority (Southern Region) by Southern Water Services Ltd for a consent to discharge screened storm sewage and/or screened sewage in an emergency to the River Len at National Grid Reference TQ 7948 5453, from Bearsted Pumping Station, Yeoman Way, Bearsted, Kent. The application states that a discharge of screened storm sewage will take place if the flow to the pumping station exceeds 160 litres per second. A discharge of screened sewage will take place in an emergency caused by total power failure or mechanical failure. The pumping station is equipped with telemetered alarms (connected to a control room manned 24 hours a day), duty and standby pumps, and an automatically tripped on-site standby generator. Bearsted Pumping Station has replaced the former Bearsted Wastewater Treatment Works.

ROAD TRAFFIC ACTS

AVON COUNTY COUNCIL

Avon County Council (Various Roads, Claverton Down to Norton St. Philip Area, City of Bath and District of Wansdyke) (Prohibition of use by Heavy Commercial Vehicles of over 7.5 Tonnes Maximum Gross Weight) (Uni-Directional Weight Restriction) Order 199 .

Notice is hereby given that the County Council of Avon proposes to make an Order under sections 1(1), 2(4) and 3(2) of the Road Traffic Regulation Act 1984, as amended the effect of which will be:

1. to prohibit any heavy commercial vehicle the maximum gross weight of which exceeds 7.5 tonnes from proceeding in any of the lengths of road specified in the Schedule to this notice, and
2. to prohibit any heavy commercial vehicle the maximum gross weight of which exceeds 7.5 tonnes from entering or proceeding in a south-easterly direction in that length of the B3110 Midford Road, which extends from a point in line with the eastern kerb-line of Southstoke Road to a point in line with the eastern kerb-line of the unnamed road (C597) running south to Twinhoe.

Item 1 only: Exemptions in the Order permit any heavy commercial vehicle to be used for or in connection with the conveyance of goods to or from any premises situated on or adjacent to any of the lengths of road; for the purposes of agriculture; in connection with any building, industrial or demolition operation; the removal of obstruction to traffic; the maintenance of the road or services therein; in the service of a local authority or water authority in pursuance of statutory powers or duties; to proceed to or from any premises situated on or adjacent to the lengths of road for the purposes of garaging or servicing the vehicle; for or in connection with the conveyance of goods for sale from the vehicle; for any fair, circus or similar event authorised by Bath City Council or Wansdyke District Council and for fire brigade, police or ambulance purposes.

Avon County Council (Stockwood Hill, Keynsham, District of Wansdyke) (Weight and Width Restriction) (Variation No. 1) Order 199 .
