#### **TOWN AND COUNTRY PLANNING ACT 1990**

The Stopping-up of Highways (Queen Street, Town Centre, Wrexham, Clwyd) Order 1995

The Secretary of State for Wales hereby gives notice that he has made an Order under section 247 of the Town and Country Planning Act 1990 to authorise the stopping-up of the length of highway described in Schedule 1 to this notice.

The stopping-up is authorised only in order to enable the development described in Schedule 2 to this notice to be carried out in accordance with planning permission granted to Crest Nicholson Properties Ltd. by Wrexham Maelor Borough Council on 25th January 1994 under ref. WRR 22373.

If any person desires to question the validity of the Order, or of any provisions contained therein, on the grounds:

- (a). that it is not within the powers of the Town and Country Planning Act 1990; or
- (b). that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act,

he may, within 6 weeks of 23rd February 1995, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

#### SCHEDULE 1

(All measurements are approximate)

The highway to be stopped up is at Wrexham Town Centre in the county of Clwyd and is that length of footway on the eastern side of Queen Street which extends from the northern wall of building No. 16 in a northerly direction for a distance of 24 metres and has a maximum width of 3 metres at its southern end and a minimum width of 2 metres at its northern end.
