DORSET COUNTY COUNCIL

The County of Dorset (Various Roads, Milton Abbas) (Restricted Roads) (No. 2) Order 1995

Notice is hereby given that Dorset County Council have made an Order under sections 82(2) and 83(2) of the Road Traffic Regulation Act 1984.

When the Order comes into operation on 24th February 1995 the effect will be to impose a 30 m.p.h. speed limit on the following lengths of road in Milton Abbas:

- (i) The Milborne St. Andrew to Milton Abbas Road (C31), from a point 78 metres north-east of its junction with the unclassified road to Long Close to its junction with Blandford Road;
- (ii) *Blandford Road*, from a point 48 metres south of its junction with the Milborne St. Andrew to Milton Abbas Road (C31) to a point 197 metres north of its junction with the northern section of *Catherines Well*;
- (iii) *Catherines Well* (southern section) to include all made up County Highways, including the service road;
- (iv) *Catherines Well* (north section) for its entire length; and
- (v) The unclassified road from Milton Abbas to Hilton from its junction with the Milborne St. Andrew to Milton Abbas Road (C31) westwards for a distance of 20 metres.
