TOWN AND COUNTRY PLANNING ACT 1990

The Stopping-up of Highways (Crouch Close, Bettws, Newport, Gwent) Order 199 .

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 247 of the Town and Country Planning Act 1990 to authorise the stopping-up of the areas of highway described in the Schedule to this notice.

If the Order is made, the stopping-up will be authorised only in order to enable development consisting of the erection of dwellings and associated road and external works to be carried out in accordance with planning permission granted to Penton Design Practice by Newport Borough Council on 22nd December 1993, under reference 93/1108/RM.

During the 28 days from 24th February 1995, copies of the draft Order and the deposited plan may be inspected during normal office hours at the offices of Newport Borough Council, Civic Centre, Newport, or may be obtained free of charge from the address, and quoting the reference, below.

Within the above-mentioned period of 28 days, any person may, by notice to the Welsh Office, Highways Directorate, Roads Administration Division, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL (quoting reference ZC 510-5-3-26), object to the making of the Order. In the preparation of an objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

SCHEDULE

(all measurements are approximate)

The areas of highway to be stopped up are at Crouch Close, Bettws, Newport, in the county of Gwent, and comprise:

- (i) the eastern footway and an irregular shaped area of highway extending to the outer kerb-line of the western footway, which extends from its junction with Monnow Way in a southerly direction for a distance of 36 metres and has a total area of 200 square metres; and
- (ii) an arc shaped area of the turning head comprising footway and highway, adjacent to property number 1, 16 metres in diameter and with a total area of 30 square metres. (481)
