

- (a) *Ringwood Crescent* (western section), both sides, from its junction with *Wollaton Road* in a northerly direction for a distance of 15 metres.
- (b) *Wollaton Road Service Road* (northern section), north side, from its junction with *Ringwood Crescent* (western section) in a westerly direction for a distance of 14 metres.
- (c) *Wollaton Road Service Road* (northern section), south side, from its junction with *Ringwood Crescent* (western section) in a westerly direction for a distance of 30 metres.

The usual exemptions will be provided. Relevant documents may be inspected at my office or at the office of the Secretary and Solicitor, Nottingham City Council, The Guildhall, Nottingham. Written objections (stating grounds and quoting ref. 6099) must be received by me by 27th March 1995.

The prohibition is intended to prevent vehicles parking close to the junction of *Ringwood Crescent* and *Wollaton Road* which are frequently causing access difficulties and visibility problems.

NOTTINGHAMSHIRE COUNTY COUNCIL

The Nottinghamshire County Council (Lenton Lane, Nottingham) (Prohibition of Waiting) Order 1995 (6053)
