THE HIGHWAYS ACT 1980

The Chester-Holyhead Trunk Road (A55) (Llanfair Pwllgwyngyll to Bryngwran) Order 199

The Secretary of State for Wales hereby gives notice that he proposes to make an Order, under sections 10, 12 and 41 of the Highways Act 1980, which will:

a. provide that roads which he proposes to construct in Anglesey in the county of Gwynedd along the following routes shall become trunk roads as from the date when the Order comes into force:

(i) a route (the main route) about 19.4 kilometres in length from a point on the existing Llanfair Pwllgwyngyll By-pass 375 metres west of the property known as Hafod near Llanfair Pwllgwyngyll and going in a westerly direction terminating at a point on a roundabout 23 metres north of the existing A5 trunk road about 336 metres east of its junction with the unclassified Bodadern to Cymuned Road; and

(ii) routes for slip roads to connect the main route with a realigned unclassified road and a new roundabout on the existing A5 trunk road east of Gaerwen and west of Rhos Helyg; and

(iii) routes for slip roads to connect the main route with roundabouts to be constructed as part of the proposals to realign the existing A5 trunk road and the A5114 to the west of Nant Turnpike; and

(iv) routes for slip roads to connect the main route with the roundabouts to be constructed as part of the proposed improvements to the A4080 classified road at Bwlwyn; and

b. provide that the lengths of the London-Holyhead Trunk Road (A5) to be superseded by the new trunk road on the main route mentioned above, shall cease to be a trunk road and shall become a classified road as from the date on which the Secretary of State notifies the County Council of Gwynedd (who will become the highway authority responsible for those lengths) that the said new trunk road is open for through traffic.

Copies of the draft Order, relevant plans and Environmental Statement may be inspected, free of charge, at all reasonable hours from 4th March 1995 to 18th April 1995 or within 6 weeks from the publication of this notice, whichever period shall expire later, at the Offices of Gwynedd County Council, County Offices, Caernarfon, Gwynedd; The Library, Lon-y-Felin, Llangefni; The Post Office, Gaerwen, Anglesey; Holyhead Public Library, Newry Street, Holyhead; the Welsh Office, Highways Directorate, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff and the Welsh Office, Highways Directorate, Government Buildings, Dinerth Road, Colwyn Bay, Clwyd.

Any person may, not later than 18th April 1995 or within 6 weeks from the date of publication of this Notice if such period shall expire later, object to the making of the Order by notice to the Secretary of State at the Welsh Office, Highways Directorate, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff, quoting ref. ZB840116D-310-2 and stating the grounds of objection. In the preparation of an objection and the statement of grounds of objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.
