

## DONCASTER BOROUGH COUNCIL

*South Yorkshire County Council (Various Roads, Askern, Carcroft, Norton, Skellow and Woodlands) (Traffic Regulation Consolidation) Order 1980 (Amendment No. 13) Order 1995.*

Notice is hereby given that on 24th March 1995 the Doncaster Borough Council made an Order under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Order which will come into operation on 18th May 1995, will be to prohibit the waiting by vehicles at any time on those roads or parts of lengths of roads at Campsall specified in the Schedule to this notice.

Exceptions to the Order will permit waiting for the purpose of picking-up and setting down passengers, loading and unloading goods, in connection with building, industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and the services therein, in pursuance of statutory powers or duties and for the collection and delivery of postal packets. The usual exceptions for disabled persons' vehicles are also included in the Order.

A copy of the Order and a map showing the restricted road may be examined at the offices of:

- (i) the Borough Engineer, Scarborough House, Chequer Road, Doncaster between the hours of 8.45 a.m. and 4.45 p.m., Monday to Friday and
- (ii) the Post Office, High Street, Campsall, Doncaster during normal opening hours.

If you wish to question the validity of the Order or of any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order you may within 6 weeks from 4th April 1995 apply to the High Court for this purpose.

## SCHEDULE

*Beech Road, Campsall* both sides from the junction with the south-western kerb-line of Churchfield Road for a distance of 22 metres in a south-westerly direction.

*Churchfield Road, Campsall:*

South-west side:

(i) From a point 43 metres south-east of its junction with the south-eastern kerb-line of Beech Road to a point 67 metres north-west of its junction with the north-western kerb-line of Park Drive.

(ii) From a point 73 metres south-east of its junction with the south-eastern kerb-line of Langleys Road to a point 38 metres north-west of its junction with the north-western kerb-line of Langleys Road.

(iii) from a point 76 metres north-west of the north-western kerb-line of Langleys Road for a distance of 17.3 metres in a north-westerly direction.

North-east side from a point 43 metres, south-west of the south-western kerb-line of Beech Road to its junction with the south-eastern kerb-line Campsall Balk Lane.

*Campsall Balk Lane, Campsall* south-east side from its junction with the north-eastern kerb-line of Churchfield Road for a distance of 44 metres in a northerly direction.

*Langleys Road, Campsall* both sides from its junction with the south-western kerb-line of Churchfield Road for a distance of 27 metres in a south-westerly direction.

*Park Drive, Campsall* both sides from its junction with the south-western kerb-line of Churchfield Road for a distance of 27 metres in a south-westerly direction. (770)

The effect of the Order which will come into operation on 18th May 1995 will be to remove the no waiting at any time on that length of Goldsborough Road which extends from a point 16 metres north-west of the north-western kerb-line of Sandringham Road for a distance of 19 metres in a north-westerly direction.
