Notice of application for a licence to abstract water

DEPARTMENT OF TRANSPORT

TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping-Up of Highways (County of Nottinghamshire) (No. 3) Order 1995" authorising the stopping-up of a length of highway at Glebe Lane, Radcliffe, Nottingham, commencing at the western boundary of the bowling green in a north-easterly direction for 47 metres to the edge of the dyke at a point 3 metres west of the entrance to Dayncourt Comprehensive School.

The stopping-up is authorised only in order to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted to Radcliffe on Trent Bowls Club by Rushcliffe Borough Council on 26th July 1994 under Ref. 94/00560/FUL.

ROAD TRAFFIC ACTS

AVON COUNTY COUNCIL

Avon County Council (Bloomfield Road, Brislington, City of Bristol) (South Eastern Zone) (Prohibition of Driving) Order 1995

Notice is hereby given that on 20th April 1995 the County Council of Avon made an Order under sections 1(1), 2(1) to (3) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended, the effect of which is:

1. to prohibit any vehicle from entering, proceeding or waiting in that length of *Bloomfield Road*, Brislington in the City of Bristol which extends from a point 45 metres south-west of its junction with Churchill Road in a south-westerly direction for a distance of 15 metres, and
2. to revoke the provisions of the County Council of Avon (Slip-Road between Whitby Road and Bloomfield road, Brislington, Bristol) (One-Way Traffic) Order 1978—this road has ceased to exist.

Exemptions in the Order permit any vehicle to enter, proceed or wait in the length of road in connection with building operations, the removal of obstruction of traffic, maintenance of the road; supply of gas, water or electricity or the pursuance of statutory powers or duties. An exemption is also provided to enable any pedal cycle to enter, proceed or wait in the length of road.

This Order makes permanent the provisions of the County Council of Avon (Bloomfield Road, Brislington, City of Bristol) (South Eastern Zone) (Prohibition of Driving) Experimental Order 1993 currently in operation which has been revoked.

The Order will come into operation on 4th May 1995 and a copy thereof together with a map, a copy of the Order to be revoked, and a copy of the Council's statement of reasons for making the Order may be inspected at the undermentioned offices (callers should report to Reception and ask for the Statutory Orders Section) during normal office hours.
