

Injection Hoses between subsea Magnus Swift wells and Magnus Platform.

Except with the consent of the Secretary of State, the 304.8 millimetre (12 inch) pipe-line, the water injection manifold and the wellhead jumpers shall only be used to convey treated sea water and the control and injection hoses shall only be used to convey well performance enhancement fluids.

The pipe-lines may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.
