ROAD TRAFFIC REGULATION ACT 1984

The A487 Trunk Road (Fishguard, Dyfed) (Prohibition of Vehicles or Combinations of Vehicles exceeding 13 metres in length) Order 199

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to prohibit any vehicle or combination of vehicles exceeding 13 metres in length from proceeding in the length of the trunk road specified in the Schedule to this Notice. The proposed Order differs from the one advertised on 7th October 1994 in that an exemption is provided to allow such vehicles to gain access to adjacent land and premises.

A suggested alternative route for vehicles affected by this prohibition will be to proceed from Fishguard Square via the A40 Trunk Road to Haverfordwest and Penblewin Crossroads, then via the A478 County Road to Cardigan and then via the A487 Trunk Road, or vice versa depending on the direction of approach. Drivers will be alerted to the prohibition by means of advance warning signs.
