## LONDON BOROUGH OF WANDSWORTH

### *Wandsworth Borough Council, Clapham Junction Controlled Parking Zone*

Notice is hereby given that the Council of the London Borough of Wandsworth propose to make—

- (a) The Wandsworth (Clapham Junction) (Parking Places) (No. ) Order 199 under sections 45, 46 and 49 of the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985;
- (b) The Wandsworth (Waiting and Loading Restriction) (Special Parking Areas) (Amendment No. ) Order 199 under sections 6 and 124 of and Part IV of Schedule 9 to the above-mentioned Act of 1984, as amended by the above-mentioned Act of 1985.

2. The general effect of the Orders would be to revoke and re-enact the provisions of the Wandsworth (Clapham Junction) (Parking Places) (No. 1) Order 1992, and further amend the Wandsworth (Waiting and Loading Restriction) (Special Parking Areas) (No. 1) Order 1994, so that—

- (a) the voucher method of payment for visitor parking in the "shared use" parking places within the existing controlled parking zone in the Clapham Junction Area (known as Zone C1) would be replaced by "pay and display" ticket parking meters (maximum stay—2 hours) and the rate of charge would be 10 pence for 10 minutes;
- (b) metered parking places (maximum stay—1 hour) would be designated in certain streets in Zone C1 (Altenburg Gardens, Beauchamp Road, Ilminster Gardens, Mossbury Road and Prested Road) and the rate of charge would be 20 pence for 20 minutes;

NOTE. The hours of operation, charges for and issue of permits, etc. in the existing Zone C1 would remain unchanged.

- (c) a system of controlled parking would be imposed in the streets within the Clapham Junction area specified in the Schedule to this notice (known as Zone C3) and the Order would provide that—

- (i) the type of parking place, the maximum parking period and the parking charge would be as set out in the Schedule;
- (ii) the parking places would operate between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays, inclusive;
- (iii) vehicles which may be left in the parking places shall be passenger vehicles, goods carrying vehicles, motor cycles or invalid carriages which have paid the appropriate charge or displayed a valid permit (unless otherwise exempt);

(iv) all permits would be issued by Wandsworth Borough Council or by the authorised agent acting for and on behalf of the Council, on application being made together with the appropriate charge;

(v) residents' permits would be issued to any person residing within Zone C3 who is the owner of a vehicle of the class specified in paragraph (a)(iii) above;

NOTE. Lavender Gardens would no longer form part of Zone C1 and only residents of Elspeth Road issued with a permit relating to C3E zone would be able to park in the spaces in that road.

(vi) visitors' permits would be issued to any household within Zone C3 and each household would be entitled to not more than thirty visitors' permits per year (sixty if the resident is aged 60 or over);

(vii) business permits would be issued to any person who occupies premises in Zone C3 and who uses such premises for non-residential purposes and is the owner of a vehicle of the class specified in paragraph (a)(iii) above.

NOTE. Each business user would be restricted to not more than 10 business permits which would be valid at any one time.  
(d) motor cycle parking places would be designated in Aliwal Road, Lavender Sweep, Mossbury Road, Mysore Road, Prested Road and Thirsk Road for which there would be no charge or time limit.

A copy of the proposed Orders referred to in paragraph 1 above, of the above-mentioned Orders of 1992 and 1994 (and of the Orders which have amended those Orders), of the Council's statement of reasons for proposing to make the Orders and of plans which indicates each road or length of road to which the Orders relate can be inspected during normal office hours on Mondays to Fridays, inclusive, until the expiration of a period of 21 days from the date on which this notice is published at The Concourse, The Town Hall, Wandsworth High Street, London SW18 2PU.
