The effect of the Order will be to introduce a prohibition of waiting on the south side of Market Place, Standish, from the junction with Church Street for a distance of 15 metres in a westerly direction and on the west side of Church Street, Standish, from the junction with Market Place for a distance of 15 metres in a southerly direction.
