EAST YORKSHIRE BOROUGH COUNCIL

*The Borough of East Yorkshire (Various Streets, Bridlington) (Traffic Regulations) Order 1995*

Notice is hereby given that the Council of the Borough of East Yorkshire ("The Council") for and on behalf of Humberside County Council, proposes to make an Order under sections 1(i), 2(i) and (ii) and Part (iv) of Schedule 9 to the Road Traffic Regulation Act 1984, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part (iii) of Schedule 9 to the said Act 1984. The effects of the proposed Order will be to:

1. Prohibit waiting and loading or unloading at any time except for operational police vehicles in part of Ashville Street, Bridlington.
2. Prohibit waiting and loading or unloading at any time in part of Princess Street, Bridlington.
3. Prohibit waiting at any time in parts of Marlborough Terrace, Bridlington.
4. Prohibit waiting except for taxis between 10 a.m. and 6 p.m. in parts of Marlborough Terrace, Bridlington.
5. Limit waiting to one hour (return prohibited within one hour) between 10 a.m. and 6 p.m. (Monday to Saturday inclusive) in parts of Promenade, Bridlington.
6. Prohibit waiting except for taxis between 6 p.m. and midnight and between midnight and 10 a.m. on any day in parts of Promenade, Bridlington.
7. Limit waiting to one hour (return prohibited within one hour) between 9 a.m. and 7 p.m. (Monday to Saturday inclusive) in part of Prince Street, Bridlington.
8. Prohibit waiting except for taxis between 11 p.m. and midnight and between midnight and 3 a.m. on any day in part of Prince Street, Bridlington.
9. Limit waiting to one hour (return prohibited within one hour) between 12 noon and 7 p.m. (Monday to Saturday inclusive) in part of Cliff Street, Bridlington.
10. Prohibit waiting between 7 p.m. and midnight and between midnight and 12 noon in part of Cliff Street, Bridlington.
11. Revoke all or part of the following Orders:

The County of Humberside (East Yorkshire Borough) (Various Streets, Bridlington) (Prohibition and Restriction of Waiting and Loading) Order 1983.

The Borough of East Yorkshire (Various Streets, Bridlington) (Prohibition and Restriction of Waiting) Order 1983.

NORTH YORKSHIRE COUNTY COUNCIL

*(A170 Pickering) Variation Order 1995*

Notice is hereby given that North Yorkshire County Council proposes to make an Order under section 1 of the Road Traffic Regulations Act 1984, the effect of which will be to:

- (1) alter the length of 40 m.p.h. restriction as set out in Part I of the Schedule,
- (2) to prohibit any vehicle from travelling at a speed of more than 30 m.p.h. on each length of road specified in Part II of the Schedule below by virtue of there being a system of street lighting in existence on this length of road, and
- (3) to vary the Traffic Regulation Order specified in Part III of the following Schedule to the extent specified or referred to in that part of the table so as to subject the road described to a 40 m.p.h. restriction.
