TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the stopping-up of areas of Blue Hall Estate, Stockton-on-Tees, Cleveland.

If the Order is made, the stopping-up will be authorised only in order to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted to Endeavour Housing Association by Stockton-on-Tees Borough Council on 26th May 1995, under ref. 95/0516/P.

The proposed Order will require improvements of Waterford Road by widening and the provision of new footpaths maintainable at the public expense for which Cleveland County Council will be the local highway authority.

Copies of the draft Order and relevant plan may be inspected at all reasonable hours during 28 days commencing on 10th August 1995, at the offices of Stockton Borough Council, Highways Department, Municipal Buildings, Church Road, Stockton-on-Tees, and may be obtained, free of charge, from the Department of Transport (quoting ref. DN5047/35/1/87) at the address stated below.

Any person may object to the making of the proposed Order within the period of 28 days commencing on 10th August 1995, by notice to the Secretary of Transport, quoting the above reference, at the office of the Director, Environment and Transport, Government Office for the North East, Wellbar House, Gallowgate, Newcastle upon Tyne NE1 4TD.

In preparing an objection it should be borne in mind that the substance of it may be imparted to other persons who may be
