Notice of applications for licences to abstract water

Notice is hereby given that applications are being made to the National Rivers Authority by ARC Ltd., of The Ridge, Chipping Sodbury, Bristol BS17 6AY, for two licences, to allow their conjunctive use, which are outlined as follows:

(a) Rivers Abstraction Licence

It is proposed to abstract water from the west bank of the River Great Ouse and transfer it to operational lagoons owned and used by ARC Ltd. Abstractions from the Rivers Great Ouse will be made at NGR TL 3640 7195, and will entail:

(i) Use 1: for make-up water in mineral washing at rates of:

42 cubic metres per hour 1,000 cubic metres per day 250,000 cubic metres per annum

during the period October to May each year.

(ii) Use 2: Seasonal augmentation to effect replenishment of lagoons and localised recharge of groundwater at total rates of:

375 cubic metres per hour 9,000 cubic metres per day 220,000 cubic metres per annum

during the period November to April each year.

The total abstraction requirement (Uses 1 and 2 combined) will entail rates of:

417 cubic metres per hour 10,000 cubic metres per day 470,000 cubic metres pe annum

during the period October to May each year.

(b) Groundwater Abstraction Licence

It is proposed to abstract groundwater from the Sand and Gravel aquifer by means of:

operational lagoons and pits located within the NGR enclosure of:

TL 3570 7215, TL 3570 7260, TL 3620 7300, TL 3660 7360, TL 3690 7330, TL 3680 7260, TL 3635 7195, TL 3605 7120. an array of tubewells locatd within the NGR enclosure of: TL 3640 7280, TL 3685 7270, TL 3620 7230, TL 3660 7230.

A total abstraction from groundwater for makeup water in mineral washing (Use I) will entail rates of:

42 cubic metres per hour 1,000 cubic metres per day 275,000 cubic metres per annum

during the period April to December each year.

(c) Aggregate Quantities for the River Abstraction and Groundwater Abstraction Licences

The River Abstraction and Groundwater Abstraction Licences will be used conjunctively.

The aggregate abstraction for make-up water in mineral washing (Use 1) from both licences combined will entail total limits on rates of:

42 cubic metres per hour 1,000 cubic metres per day 365,000 cubic metres per annum

during the period January to December each year.

The River Abstraction for seasonal augmentation (Use 2) is not included in the above aggregate totals.
