

*The Wigan Borough (Highfield Grange Avenue, Wigan) (Bus Stop Clearway) Order 1995*

Notice is hereby given that the Wigan Borough Council, in exercise of its powers under section 1 of the Road Traffic Regulation Act 1984, has made the Wigan Borough (Highfield Grange Avenue, Wigan) (Bus Stop Clearway) Order 1995, which will come into operation on 28th August 1995.

The effect of the Order is to introduce a bus stop clearway along the whole length of Highfield Grange Avenue, Wigan.

A copy of the Order and of the relevant map may be inspected at the New Town Hall, Library Street, Wigan, between 9 a.m. and 4.30 p.m., on any day from Monday to Friday.

Any person who desires to question the validity of the Order or any provision contained therein on the ground:

- (b) that any requirement of the said section 1, or of Part III of Schedule 9 to the said Act, or of any regulation made under the said Part III of Schedule 9 has not been complied with,

may within 6 weeks of 4th August 1995, make application for the purpose to the High Court.

*The Wigan Borough (Unnamed Passageway between Nos. 4 and 6) Edinburgh Drive, Wigan (Prohibition of Driving) Order 1995*

Notice is hereby given that the Wigan Borough Council, in exercise of the powers under section 1 of the Road Traffic Regulation Act 1984, proposes to make the Wigan (Unnamed Passageway between Nos. 4 and 6) Edinburgh Drive, Wigan (Prohibition of Driving) Order 1995.

The effect of the Order will be to prohibit Driving on Unnamed passageway between Nos. 4 and 6 Edinburgh Drive, Wigan, from its junction with Edinburgh Drive, for a distance of 5 metres in a south-westerly direction.

## HIGHWAYS ACT 1980, SECTION 116

*Stopping-up of Part of Radcliffe Road, Belmont Road and North Albion Street, Fleetwood*

Notice is hereby given, pursuant to section 116 of and the 12th Schedule to the Highways Act 1980, that at 10 a.m., on Thursday, 14th September 1995, application will be made by the Wyre Borough Council to the Magistrates' Court sitting at the Fleetwood Magistrates' Court, The Esplanade, Fleetwood for Orders authorising the stopping-up of the following lengths of public highways on the ground that they are unnecessary:

- (1) Part of Radcliffe Road, Fleetwood from the north-easterly kerb-line of Elm Street for 85 metres in a north-easterly direction, a total area of 680 square metres.
- (2) Part of Belmont Road, Fleetwood from the south-westerly kerb-line of Elm Street for 10 metres in a south-westerly direction, a total area of 155 square metres.
- (3) Part of North Albion Street, Fleetwood from the rear of the north-westerly kerb-line of Lord Street for 15.5 metres in a north-westerly direction, a total area of 110 square metres.

These lengths of highways are shown coloured pink on a plan available for inspection by members of the public, free of charge, at all normal office hours at the Wyre Civic Centre, Breck Road, Poulton-le-Fylde and the Fleetwood Area Office, 47 Lord Street, Fleetwood, Lancashire.
