Notice is hereby given that the Dyfed County Council propose to make an Order under sections 1(1) and (2), 2(1) to (3) and 4(2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 "the Act").

The effect of this Order will be:

(1) To prohibit waiting at any time on the sides of road specified in Schedule 1 to this notice.
