*The County of Humberside (Kingston-upon-Hull) (Inglemire Avenue/Inglemire Lane/Marydene Drive) (Prohibition and Restriction of Waiting) Order 1995.*

Notice is hereby given that the Kingston-upon-Hull City Council, on 16th August 1995, made the above Order under the Road Traffic Regulation Act 1984. The Order will come into operation on 25th August 1995.

*The County of Humberside (Kingston-upon-Hull) (Waddington Court/Cottingham Road) (Prohibition of Waiting) Order 1995*

Notice is hereby given that the Kingston-upon-Hull City Council, on 16th August 1995, made the above Order under the Road Traffic Regulation Act 1984. The Order will come into operation on 21st August 1995.

The effect of the Order is to place double yellow lines around Waddington Court and they will extend onto Cottingham Road for 10 metres at either side of Waddington Court.

The purpose of the Order is to prevent the obstruction of private access on Waddington Court by parked vehicles and ensure clear sight lines at the junction of Waddington Court/Cottingham Road.
