WILTSHIRE COUNTY COUNCIL

The County of Wiltshire (Various Roads, Warminster) (Prohibition and Restriction of Waiting) Order 1982 (Amendment No. 5) Order 1995

Notice is hereby given that, on 16th August 1995, the Wiltshire County Council made an Order under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at all times on the following lengths of road in Warminster:

Ash Walk:

(i) west side, from a point 68 metres north of its junction with Silver Street to a point 82 metres north of that junction.

(ii) west side, from a point 102 metres north of its junction

with Silver Street to a point 20 metres north-west of its northern junction with Manor Gardens.

(iii) east side, from a point 16 metres north of its southern junction with Manor Gardens to a point 20 metres north-west of its northern junction.

Manor Gardens (North), both sides, from its northern junction with Ash Walk to a point 15 metres north-east of that junction. West Street, north side, from a point 20 metres east of its junction with Grovelands Way (east) to a point 20 metres west of that iunction.

Grovelands Way (East), both sides, from its junction with West Street to a point 10 metres north-west of that junction.

Weymouth Street, south-east side, from a point 204 metres south-west of its junction with Market Place/High Street to a point 268 metres south-west of that junction.

Safeway Access:

(i) north-east side, from its junction with Weymouth Street to a point 33 metres north-west of that junction.

(ii) south-west side, from its junction with Weymouth Street to a point 22 metres north-west of that junction.

Deverill Road:

(i) east side, from a point 47 metres south of its junction with Fore Street to a point 71 metres north of that junction.

(ii) west side, from a point 47 metres south of its junction with Fore Street to a point 11 metres north of that junction.

(iii) west side, from a point 35 metres north of its junction with Fore Street to a point 71 metres north of that junction. Fore Street, both sides, from its junction with Deverill Road to a

point 15 metres west of that junction.

Church Street:

(i) east side, from a point 23 metres north-west of its junction with Vicarage Street to a point 151 metres north of that junction.

(ii) west side, from a point 23 metres north-west of its junction with Vicarage Street to a point 43 metres north-west of that junction.

(iii) west side, from a point 76 metres north-west of its junction with Vicarage Street to a point 129 metres north of that junction.

East Street:

(i) north-east side, from a point 12 metres north-west of its junction with The Furlong to a point 12 metres south-east of that junction.

(ii) north-east side, from a point 29 metres north-west of its junction with Imber Road to a point 35 metres south-east of that junction.

(iii) south-west side, from its junction with East End Avenue to its junction with Smallbrook Road.

The Furlong, both sides, from its junction with East Street to a point 10 metres north-east of that junction.

Boreham Road:

(i) south-west side, from a point 68 metres north-west of its junction with Chain Lane to a point 97 metres north-west of that junction (Gibbs Transport Ltd. Access).

(ii) south-west side, from a point 13 metres north-west of its junction with Chain Lane to a point 13 metres north-west of that junction.

Chain Lane, both sides, from its junction with Boreham Road to a point 10 metres south-west of that junction.

A copy of the Order and plan may be inspected at the offices of the Chief Executive's Department (Legal Division), County Hall, Trowbridge, during normal office hours.

Any person aggrieved by the Order and desiring to question the validity of the Order, or of any provision contained in the Order, on the grounds that it is not within the powers of the relevant section of the above Act, or on the grounds that any requirement of that section or of Part III of Schedule 9 of the Act, or any regulation made under the said Schedule has not been complied with in relation to the Order, may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.

The Order will be operative as from 21st August 1995.

NORTH YORKSHIRE COUNTY COUNCIL

North Yorkshire County Council (Prohibition and Restriction of Waiting) (Various Roads, Helmsley) Order 1995

Notice is hereby given that North Yorkshire County Council proposes to make an Order under sections 1(1), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit the waiting of vehicles:

(a) at any time in any length of road specified in Part I of the following table;

(b) between the hours of 8 a.m. and 6 p.m., 21st March to 31st October, in any length of road specified in Part II of that table.

The proposed Order includes certain exemptions in respect of the prohibitions referred to in sub-paragraphs (a) and (b) including one in respect of the loading or unloading of goods.

Waiting prohibited at all times with exemptions

Castlegate, south-west side, from a point opposite the southern gable wall of No. 36 Castlegate extending southerly and westerly towards Buckingham Square for a distance of 15 metres.

High Street, (B1257) (carriageway only), north-east side, from a point 183 metres north-west of its junction with the centre line of Cannons Garth Lane, for a distance of 62 metres in a southeasterly direction.
