GWYNEDD COUNTY COUNCIL

The County of Gwynedd (Back High Street, Tywyn) (Prohibition of Waiting) Order 1995

Notice is hereby given that the County Council of Gwynedd proposes to make an Order under sections 1(1) and (2), 2(1) to 2(3) and 4(2) of the Road Traffic Regulation Act 1984.

The effect of the Order will be to prohibit vehicles from waiting at any time on the length of road specified in the Schedule hereto.

Exceptions will permit waiting for:

- (a) picking-up and setting down passengers;
- (b) loading or unloading goods;

and where necessary in connection with:

- (c) certain building operations;
- (d) the maintenance of the road;
- (e) the supply of gas, electricity, water or other statutory undertakings;
- (f) the exercise of local authority powers and functions;
- (g) the exercise of postal functions;
- (h) fire brigade, ambulance and police purposes;
- (i) and in certain circumstances when the vehicle is a disabled person's vehicle.

The draft Order, together with a map showing the lengths of roads concerned and a statement of the Council's reasons for proposing to make the Order may be examined at:

- (a) County Offices, Caernarfon; and
- (b) The Post Office, Tywyn

during normal business hours.

The County of Gwynedd (Road Leading to Ysgol y Gorland, Tremadog) (Prohibition of Waiting) Order 1995

Notice is hereby given that on 1st August 1995, the County Council of Gwynedd made an Order under sections 1(1) and (2), 2(1) to 2(3) and 4(2) of the Road Traffic Regulation Act 1984.

HAMPSHIRE COUNTY COUNCIL

Street Parking in Winchester

Notice is hereby given that Hampshire County Council proposes making a Controlled Zone Order as follows:

Effects of Order: To replace existing street parking arrangements in Winchester with a new Controlled Parking Zone covering a large part of the City. The Controlled Zone will be operational between 8 a.m. and 6 p.m., Mondays to Saturdays. Exemptions will be included for loading/unloading in all parking places and the "no waiting" areas, except for a few of the busiest streets where they will be restricted at peak times or prohibited. There will be no waiting at any time on most of the main routes in and out of the City. Many streets will have permit parking only with other areas having short-term public parking bays where permit holders will be exempt.

The City will be divided into 23 permit zones; residents, businesses and other groups within each zone will be entitled to purchase a permit or permits valid for that zone. In the case of some addresses in boundary roads permits will also be available for adjacent zones. Students in multi-occupation accommodation who are not full-time residents will not be eligible for resident's permits.

The usual exemptions will apply in respect of disabled drivers parking including parking without time limit in all parking places.

Types of permit, their availability and fees payable are set out as follows. Except where indicated permits will be transferable between vehicles.

Permit	Number per address/business/group	Fee per permit per annum
Residents and/or their visitors (Inner Area)	1	£10
Residents and their visitors (Outer Area)	4 (2 of which are not transferable to visitors)	£10
Business-Customers (Inner Area)	1 (1 hour time limit)	£30
Business-Customers (Outer Area)	5 (4 hour time limit)	£30
