DURHAM COUNTY COUNCIL

HIGHWAYS ACT 1980, SECTION 116 AND SCHEDULE 12

Ipswich Borough Council (St. Stephens Church Lane) Public Path Diversion Order 1992

Notice is hereby given that on 14th August 1995, Ipswich Borough Council confirmed the above-named Order.

The effect of the Order as confirmed is to extinguish the public rights of way over land shown by red colouring on the map contained in the Order and to create a public footpath on the land shown by red hatching on the map.

The Order becomes operative as from 5th September 1995, but if a person aggrieved by the Order desires to question the validity of it, or of any provision contained in it, on the grounds that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act as amended, or of any regulation made thereunder has not been complied with in relation to the Order, he may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from the date on which this notice is first published, make an application for the purpose to the High Court.

KENT COUNTY COUNCIL

HIGHWAYS ACT 1980

The County Council (Ramsgate Harbour Approach Road Classified Road) (Side Roads) Order 1995

Notice is hereby given that Kent County Council has made, and submitted to the Secretary of State for Transport for confirmation, an Order under sections 14 and 125 of the Highways Act 1980 for authorising the Council:

- to improve, raise, lower or otherwise alter highways,
