7. To introduce a series of road humps in accordance with section 90A(i) of the Highways Act 1980, as specified in the Schedule to this notice.

# **HEATHROW AIRPORT LIMITED**

The Heathrow Airport-London (Restriction of Waiting on Bus Stops) Order 1995

Heathrow Airport Limited (being a wholly owned subsidiary of BAA plc), in exercise of its powers under sections 6 and 7, Schedules 1 and 9 of the Road Traffic Regulation Act 1984, as amended by New Roads and Street Works Act 1991, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, and as having effect by virtue of sections 1, 2 and 65 of the Airports Act 1986 and the Aerodrome Traffic (Heathrow) Order 1976, hereby makes the following Order:

1. Commencement and Citation

This Order shall come into operation on 24th August 1995, and may be cited as the Heathrow Airport-London (Restriction of Waiting on Bus Stops) Order 1995.

Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Heathrow Airport—London (Restriction of Waiting on Bus Stops) Order 1979 and the Heathrow Airport—London (Restriction of Waiting on Bus Stops Order 1979) (Amendment No. 1) Order 1994, are hereby revoked.

3. Interpretation

(i) In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:

"bus stop" means any area within or adjacent to any length of road specified in the Schedule marked as Diagram 1025 (or variant) of the Traffic Signs and General Directions 1994;

"enactment" means any enactment, whether public, general or local, and includes any order, byelaw, rule, regulation, scheme or any other instrument having effect by virtue of an enactment:

"road" includes a length of road and any part of the width of road:

'buses" has the same meaning as the Transport Act 1985;

"emergency service vehicle" means any vehicle which is not used for fire brigade, ambulance or police purposes but which provides a necessary emergency service;

"London local service licence" has the same meaning as in the Transport Act 1985;

prescribed hours" means any time of the day or night throughout the week;

"schedule" means a Schedule to this Order;
"telegraph line" has the same meaning as the Telegraphic Act 1878.

(ii) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by any subsequent enactment.

(iii) For the purpose of this Order, a vehicle shall be deemed to wait on a bus stop if any point in that area is below the vehicle or its load (if any) and the vehicle is stationary.

(iv) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

(v) The restriction imposed by this Order is in addition to and not in derogation of any restriction, requirement or prohibition imposed by any other enactment.

# PART II

Restrictions Applicable to the Roads Specified in Schedule 1 to this

4. No person shall cause or permit any vehicle to wait on a bus stop during the prescribed hours.
